WITHDRAWAL ORDER**

WHEREAS, recognition was granted to the institution namely Ambika D.El.Ed College, Plot/Khasra No. 392/ga, Gadwal Village and Post, Gadwal City and Taluk, Mahaboobnagar District – 509125, Telangana run by Ambika Educational Society, Plot No. 7-5-18/A, Kuntaveedhi Street, Gadwal Village and Post, Gadwal City and Taluk, Mahaboobnagar District – 509125, Telangana vide SRC (NCTE) order no. F.SRO/SRCAPP1636/D.El.Ed/AP/2015/66107 dt. 31.05.2015 for conducting D.El.Ed course of twp-years duration with an annual intake of 50 students from the academic session 2015-2016.

AND WHEREAS, the institution has submitted its representation on 14.07.2017 requesting to change the Village name in the Formal Recognition Order as Pudur Village, Gadwal Mandal. The SRC in its 343rd meeting held on 01st & 02nd August, 2017 considered the matter and decided as under;

1. The basic documents give the address as 'Pudur Village, Gadwal Mandal'.
2. Their request for correcting the address, in the Recognition Order, accordingly is accepted.
3. Issue.

AND WHEREAS, as per the decision of SRC was issued a vide Corrigendum Order No.F.SRO/NCTE/SRCAPP1636/D.El.Ed/TS/2017-2018/94296 to the institution on 08.08.2017.

AND WHEREAS, the institution vide letter dated 23.09.2019 informed that the State Govt. of Telangana has not granted permission to run the Institution and requested for return of FDR. The SRC in its 381st meeting held on 31st Oct & 01st Nov, 2019 considered the matter and decided as under;

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the Institution were carefully considered by the SRC and the following observations were made:-

The Committee decided that to withdraw the recognition granted to Ambika D.El.Ed. College, Plot/khasra No. 392/ga, Gadwal Village and Post, Gadwal City and Taluk, Mahaboobnagar District- 509125, Telangana for conducting D.El.Ed. course under clause 17(1) of NCTE Act, 1993 on the request of the institution vide its letter dated 08.08.2017. However, the FDRs towards Reserve Fund and Endowment Fund/ No Objection Certificate

(NOC) for encashment of FDRs will be issued by the Regional Director on the submission of the following:

- (a) NOC from the affiliating body.
- (b) NOC from the staff/faculty.
- (c) Resolution of the management to the effect for closure of the course

NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of **Ambika D.El.Ed College, Plot/Khasra No. 392/ga, Gadwal Village and Post, Gadwal City and Taluk, Mahaboobnagar District – 509125, Telangana** run by **Ambika Educational Society, Plot No. 7-5-18/A, Kuntaveedhi Street, Gadwal Village and Post, Gadwal City and Taluk, Mahaboobnagar District – 509125, Telangana** for conducting D.El.Ed programme of two years duration with an annual intake of 50 students (1 units) from the next academic session starts after issuance of this order.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
