WITHDRAWAL ORDER**

Recognition was granted to the institution namely **Balaji Institute of Education, Maheshwaram, Laknepally, Narasampet, Warangal District-506331, Telangana** run by **Mahashwara Educational Society, Plot No. 1-1-71, Beside Pavani Nursing Home Street, Narasampet Village & Post Office, Waranagal-506132, Andhra Pradesh** vide SRC (NCTE) order no. F.No.SRCAPP1707/D.El.Ed-/AI/AP/2015/62235 dt. 03.03.2015 for conducting D.El.Ed. course of two-year duration with an annual intake of 50 students.

**AND WHEREAS**, the FDRS were originally return to the institution on 29.07.2015. The institution vide letter dated 18.05.2019 received on 28.05.2019 requested for closure of D.El.Ed-AI. programme. The SRC in its 380<sup>th</sup> meeting held on 18<sup>th</sup> – 19<sup>th</sup> September, 2019 considered the matter and decided as under;

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The Committee decided that to **withdraw the recognition granted to Balaji Institute of Education, Maheshwaram, Laknepally, Narasampet, Warangal District-506331, Telangana** for conducting **D.El.Ed - AI** course under clause 17(1) of NCTE Act, 1993 on the request of the institution vide its letter dated 18.05.2019. However, the FDRs towards Reserve Fund and Endowment Fund/ No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director on the submission of the following:

- (a) NOC from the affiliating body.
- (b) NOC from the staff/faculty.
- (c) Resolution of the management to the effect for closure of the course

**NOW, THEREFORE**, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of **Balaji Institute of Education, Maheshwaram, Laknepally, Narasampet, Warangal District-506331, Telangana** run by

**Mahashwara Educational Society, Plot No. 1-1-71, Beside Pavani Nursing Home Street, Narasampet Village & Post Office, Waranagal-506132, Telangana** for conducting D.El.Ed-AI programme of two years duration with an annual intake of 50 students (1 units) on the grounds mentioned above.

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website [www.ncte-india.org](http://www.ncte-india.org) within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
