WITHDRAWAL ORDER**

WHEREAS, the recognition was granted to the institution, namely Sri Venkateshwara D.Ed College, Khasara No.298, 299, Plot No.615, Durajpally Village and Post, Chivvemla Taluk, Suryapet City, Nalgonda District, Pon-508214, Andhra Pradesh run by Pratishta Educational Society, Plot No.298, Nerducherla Road, Durjpally Village and Post, Chivvemla(m) Taluk, Suryapet City, Nalgonda District, Pin-508214, Andhra Pradesh for conducting D.El.Ed. course of two years duration with an intake of 50 students vide order No. F.No.SRCAPP646/D.El.Ed/AP/2012/45598 dated 29.08.2012.

AND WHEREAS, the institution vide letter dated 01.05.2019 requesting to withdraw the recognition of the D.El.Ed programme. The SRC in its 380th meeting held on 18th - 19th September, 2019 considered the matter and decided as under;

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The Committee decided that to withdraw the recognition granted to Sri Venkateshwara D.Ed College, Khasara No.298, 299, Plot NO.615, Durajpally Village and Post, Chivvemla Taluk, Suryapet City, Nalgonda District, Pon-508214, Telangana State for conducting D.El.Ed. course under clause 17(1) of NCTE Act, 1993 on the request of the institution vide its letter dated 02.05.2019. However, the FDRs towards Reserve Fund and Endowment Fund/ No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director on the submission of the following:

- (a) NOC from the affiliating body.
- (b) NOC from the staff/faculty.
- (c) Resolution of the management to the effect for closure of the course

NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of Sri Venkateshwara D.Ed College, Khasara No.298, 299, Plot No.615, Durajpally Village and Post, Chivvemla Taluk, Suryapet City, Nalgonda District, Pin-508214, Telangana run by Pratishta Educational Society, Plot No.298, Nerducherla Road, Durjpally Village and Post, Chivvemla(m) Taluk, Suryapet City, Nalgonda District, Pin-508214, Telangana for conducting D.El.Ed programme of two years duration with an annual intake of 50 students (1 unit) on the grounds mentioned above.

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
