AND WHEREAS, the institution vide letter dated 02.05.2019. The SRC in its 380th meeting held on 18th – 19th September, 2019 considered the matter and decided as under;

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The Committee decided that to withdraw the recognition granted to Chenna Keshava College of Education, Khasara/Plot, No. 43/AA, Burugupally Village, Vikarabad Post & Taluk, Randareddy District-501101, Telangana State for conducting D.El.Ed. course under clause 17(1) of NCTE Act, 1993 on the request of the institution vide its letter dated 22.05.2019.

Since the institution submitted requested documents for closure therefore FDR/NOC for enhancement of Endowment Fund & Reserve Fund be issued.

NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of Chenna Keshava College of Education, Khasara/Plot No.43/AA, Burugupally Village, Vikarabad Post & Taluk, Rangareddy District-501101, Telangana run by Sri Chenna Keshava Educational Society, Plot No.4-5-25, Alibagh Road, Vikarabad Village, Post & Taluk, Rangareddy District-501101, Telangana for conducting D.El.Ed programme of two years duration with an annual intake of 50 students (1 unit) on the grounds mentioned above.
