<u>ORDER</u>

WHEREAS in terms of Section 14(1) of the NCTE Act, 1993 **Sri Sai Educational Society, Kadapa District, Andhra Pradesh** has submitted an application to the Southern Regional Committee of NCTE for grant of recognition for conducting **D.Ed** course with an annual intake of **50** on **09.01.2007**.

- 2. AND WHEREAS on scrutiny of the application submitted by the institution, the documents attached therewith, the affidavit and the input received from the visiting team in the form of report and videography, institution/ society fulfills the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the **Elementary** teacher education programme such as instructional facilities, infrastructural facilities, library, accommodation, financial resources, laboratory etc. for running the programme and has selected/ appointed duly qualified teaching staff as per NCTE norms.
- 3. NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) 15(3) (a) of the NCTE Act, 1993, the Southern Regional Committee, NCTE hereby grants permission to Sri Venkateshwara D.Ed College, S.No.1008/3, Near H.No.4/139, Kammavaripalli Gramam, Ranga Samudram Village, Porumamulla Mandal, Kadapa District-516193, Andhra Pradesh for conducting D.Ed Course of Two years duration with an annual intake of 50 students under clause 7(11) of NCTE(Recognition Norms & Procedure) Regulations, 2007 subject, to fulfillment of the following conditions:
- I. The admission of students shall be done only after affiliation by the examining body before the commencement of the academic year and the admission of students shall be completed well before the cut off date prescribed by the Examining/Affiliating body for the academic year 2008-2009 failing which the recognition will be deemed to be from the next academic year that is 2009-10.
- II. Formal orders for recognition/permission will operate for 2008-2009 only if the requirement of 180 teaching days in the session would be fulfilled as per calendar of the University/ Affiliating Body.
- III. The endowment fund of Rs.5 lakhs and reserve fund of Rs.3 lakhs kept in joint account with SRC, NCTE should be maintained always. Loan raising or mortgaging of FDRs shall not be done.

- The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time. IV.
- The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE(Recognition Norms & V. Procedure) Regulations,2007.
- The institution shall ensure that the required number of academic staff for VI. conducting the course is always in position.
- Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/ 4. Body, the State Government etc, as applicable.
- The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly 5. audited by a Chartered Accountant.
- The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:-6.
 - Copy of the Application Form (i)
 - Land and Building Particulars (ii)
 - Staff Profile (iii)
 - **Recognition** letter (iv)
 - Information for having fulfilled the norms & standard and other required (v) conditions.
 - If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the 7. Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.
