 - Ь. The institution will ensure that the permanent building is constructed within a period of 3 years on the acquired land.
 - d. The institution has selected the Professor and Four Lecturers for the said course.
- Now therefore, in exercise of the powers vested under Section 14(1) of the NCTE Act, 1993, the Southern Regional Committee hereby grants recognition to Sri Sarada Physical Education for Women, Fairlands, Salem -636016, Tamilnadu to offer M.P.Ed course of Two Years duration from the academic session 2005-06 with an annual intake of 30 students, subject to duffillment of the following:
 - a) The institution will-ensure that Five exclusive faculty members (Professor and Four Lecturers) duly approved by the attiliating university are in position for an intake of 30 students and a report to this effect shall be sent to the Southern Regional Committee immediately and in any case before commencement of the course.
 - b) The institution shall shift to its own premises within three years from the date of recognition (in case the course is started in temporary premises)

- c) The institution shall, within one month of the receipt of recognition order, convert the endowment fund account into a joint account to be operated along with an official of the Regional Committee.
- d) The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations.
- 4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like the State Government etc.
- 5. The institution shall submit to the Regional Committee a Performance oppraisal Report at the end of each academic year along with a copy of the approval of the affiliating body to the appointment of faculty members, and the statement of annual accounts duly audited by a Chartered Accountant.
- 6. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued thereunder, the Southern Regional Committee may withdraw the recognition under the Provisions of Section 17(1) of the NCTE Act, 1993.
