ORDER

WHEREAS, in exercise of the powers conferred by sub-section(2) of Section 32 of the National Council for Teacher Education Act, 1993(73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 1.12.2014.

2. AND WHEREAS, the institution **Sri. Shambulingeshwara College of Physical Education, K.R. Pet Road, Jayanagar Extension, Pandavapura, Mandya-571427, Karnataka** has by affidavit consented to come under New Regulations and sought for 100 intake in B.P.Ed.

3. AND WHEREAS, on scrutiny it is found that the institution has not shifted to its own premises as stipulated in its Formal Recognition order dated **30.01.2006**.

4. AND WHEREAS, it has been decided to permit the institution to have one basic unit of 100 students (two sections of 50 each) subject to the institution fulfilling following conditions namely,

- I. The institution shall submit all documents including Land, Building, Encumbrance Certificate, Land Use Certificate, Building Plan, approved staff list, pertaining to shifting to own premises to the SRC before 31st July, 2015 failing which recognition will be withdrawn.
- II. The Regional committees shall inspect the proposed premises during August-September-October, 2015 and if on inspection it is found that the institution does not fulfil required norms of infrastructure recognition will be withdrawn.
- III. The institution shall appoint additional staff as per Regulations, 2014 and submit approved staff list to the Regional Committees with required documents by October 31, 2015.
- IV. The Regional Committees shall arrange for verification of documents, check adherence by 20 Feb, 2016. If it is found by the Regional Committee that the institution fails to comply with the new teaching staff requirements, the institution shall not be permitted to admit students for the academic year 2016-2017.

5. NOW THEREFORE, in the light of the above and in terms of Section 14(3) (a) of NCTE, Act and in accordance with the Regulations, 2014, the Southern Regional Committee, NCTE hereby grants recognition to **Sri. Shambulingeshwara College of Physical Education, K.R. Pet Road, Jayanagar Extension, Pandavapura, Mandya-571427, Karnataka** for conducting B.P.Ed programme of two years duration with an annual intake of one basic unit of 100 (two sections of 50 students each) from the academic session **2015-16 subject to fulfilment of the conditions mentioned at 4(I) and 4(II) herein before 31st July, 2015 and those mentioned at 4(III), before 31.10.2015.**

6. Further, the recognition is subject to fulfilment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc. as applicable.

7. The institution shall submit to the Regional Committee a Self- Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

8. The institution shall maintain & update its web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:-

- a) Sanctioned programmes along with annual intake in the institution;
- b) Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c) Name of faculty members who left or joined during the last, quarter;
- d) Names of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- e) Fee charged from students;
- f) Available infrastructural facilities;
- g) Facilities added during the last quarter;
- h) Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i) The affidavit with enclosure submitted along with application.
- j) The institution shall be free to post additional relevant information. if it so desires.
- k) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

If the institution Contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and Orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition by the Regional Committee under the provisions of Section 17(1) of the NCTE Act.
