### **ORDER**

WHEREAS, Prabhu Educational Society, Plot No. 1-7-19/1, NSPT Road, Mahabubabad, Warangal, Andhra Pradesh had submitted an application for grant of recognition to Sri Vivekananda College of Elementary Education, 590/1, 591/1/2, Edulapussapally Road, Mahabubabad, Warangal, Andhra Pradesh for D.Ed course in the office of SRC-NCTE on 30.10.2008.

**AND WHEREAS**, the file was under process and in the meanwhile, in view of the recommendation of the State Government of Andhra Pradesh is received vide letter dated 7.1.2009 not to further recognize/permit the institutions for conducting B.Ed, D.Ed, Physical Education, Language Pandit Courses.

AND WHEREAS, SRC in its 169th meeting held on 12th and 13th January, 2009 having considered the letter dated 7.1.2009 of State Government of Andhra Pradesh decided to give effect to the above decision of State Government of Andhra Pradesh as such, with immediate effect. A letter dated 7.2.2009 forwarded by Principal Secretary of Education requesting not to accord further recognition/permission to the new colleges/private B.Ed/D.Ed, Physical Education, Language Pandit in the State of Andhra Pradesh as the above colleges are exceeding in numbers than required letter dated 17th March, 2009 has been received from NCTE-Hqrs., informing that the "other courses like B.Ed, D.Ed and Physical education courses have further been considered in the NCTE and it has been decided that no further recognition/permission to any institution in the State of Andhra Pradesh be considered by SRC for the academic session 2009-10 for B.Ed, D.Ed and Physical Education courses also. The State Government vide letter dated 20.3.2009 informed that it has been decided to recommend the name of the institution. The letters dated 7.1.2009, 7.2.2009, 17.3.2009 and 20.3.2009 were considered by SRC in its 172<sup>nd</sup> meeting held on 25<sup>th</sup> and 26<sup>th</sup> March, 2009 and SRC decided to accept the recommendation of the State Government of Andhra Pradesh not to grant recognition to any of the teacher training institutions in the State of Andhra Pradesh for the year 2009-10 and decided to close the applications. As per decision of SRC the closure order was issued on 18.4.2009.

**AND WHEREAS**, the institution has approached to Honorable High Court in W.P 26814 of 2010. The Hon' ble High Court has directed vide Order dated 29-10-2010 as follows:-

"It may be true that the state Government as well as the first respondent have reviewed the situation as to the necessity or otherwise of according permission to establish new colleges of education in the state in future and that the existing institutions are found to be adequate. However, the right that is accrued to the petitioners on the basis of their application and the consideration thereof by the first respondent cannot be taken away on account of the change of policy. It is settled principle of law that whenever an application is made, it must be considered and processed in accordance with the provisions of law or the policy that existed as on the date of presentation. Subsequent changes may apply to the applications that are made there after hence, this writ Petition is also disposed of reiterating the same directions as noticed supra. No costs."

**AND WHEREAS,** SRC had issued a deficiency letter dated 30.10.2008. The institution submitted its reply dated 06.01.09.

**AND WHEREAS,** SRC in its 198<sup>th</sup> meeting held on 24<sup>th</sup> –26<sup>th</sup> November, 2010 considered the matter and all relevant documents and decided to cause inspection to examine whether the institution fulfils all the requirements as per the norms, for the proposed programme, subject to the condition that the institution had rectified the deficiencies, if any, as per the norms. Accordingly inspection of the institution was carried out on 19.01.2011.

**AND WHEREAS,** SRC in its 201<sup>st</sup> meeting held on 22<sup>nd</sup>-23<sup>rd</sup> February, 2011 considered the VT Report, VCD and all the relevant documentary evidences and it was decided to issue Show cause Notice Under Section 17 of NCTE Act. accordingly, a Show Cause Notice was issued to the institution for seeking clarification on 18.03.2011.

**AND WHEREAS,** the institution has submitted its written representation on 15.04.2011. SRC in its 204th meeting held on 27<sup>th</sup> and 28<sup>th</sup> April 2011 considered the reply decided to call remarks from the VT members immediately for the following:-

• The tampering/overwriting (applying white fluid) of essential data of the VT report on page -5,6,16,19 & 21 of the VT report. The VT members are requested to submit the reply within 15 days from date of this letter, without fail.

**AND WHEREAS,** as per direction of SRC a letter was issued to both VT members on 26.05.2011. The VT Members submitted reply vide letter dated 09.06.11 and 22.06.11. The replies of VT members were duly considered in the 208<sup>th</sup> SRC Meeting held on 13<sup>th</sup> and 14<sup>th</sup> July 2011 and the committee decided that the corrections were genuine and to process the visiting team report of the institution for further action.

**AND WHEREAS,** the Committee in its 211<sup>th</sup> meeting held on 21<sup>st</sup>-23<sup>rd</sup> September 2011 considered the VT Report, VCD and all the relevant documentary evidences and it was decided to serve Show cause Notice under Section 17 of NCTE Act. accordingly, a show cause notice was issued to the institution on 15.11.2011 and the institution had submitted its replyon14.11.2011

**AND WHEREAS**, the SRC in its 215<sup>th</sup> meeting held on 12<sup>th</sup> and 13<sup>th</sup> December, 2011 considered the reply of the institution dt. 14.11.2011, VT Report, VCD and all the relevant documentary evidences and decided to serve Show cause Notice under Section 14 of NCTE Act. accordingly, notice was issued to the institution on 31.1.2012. The institution has submitted written representation on 27.1.2012.

**AND WHEREAS,** the SRC in its 217<sup>th</sup> meeting held on 12<sup>th</sup>-13<sup>th</sup> February, 2012 considered the reply of the institution dt. 27.01.2012, VT Report, VCD and all the relevant documentary evidences and decided to serve Final Show cause Notice under Section 14 of NCTE Act.

AND WHEREAS, accordingly, a final show cause notice was issued to the institution on 14/03/2012. However the institution submitted written representation on 12/03/2012 based on the minutes available on SRC website.

AND WHEREAS, on careful perusal of the original file of the institution, reply of the institution, other related documents, Act of NCTE, 1993, Regulations and guidelines of NCTE published from time to time laid on the table, the Regional Committee decided to issue Letter of Intent for grant of recognition to D.Ed course of two years duration with an annual intake of 50(Fifty only)(one unit) for the academic year 2012-13 subject to the appointment of qualified staff through duly constituted selection committee as per the Norms of NCTE/State Government/Affiliating University and be given effect before the commencement of the academic session.

**AND WHEREAS,** as per direction of Southern Regional Committee in its meeting 221<sup>st</sup> letter of intent prior to recognition was issued to applicant institution on 07.05.2012. In response to this office letter dated 07.05.2012 the institution has submitted reply vide letter dated 03.07.2012.

**AND WHEREAS**, the Committee in its  $228^{th}$  meeting held on  $24^{th} - 25^{th}$  July 2012 to the LOI dated on 03/08/2012 considered the reply and all the relevant documentary evidences and decided to serve Notice Under NCTE Act for the following:-

• The Institution has not appointed Lecturer in Art Education and Physical Education per NCTE norms 2009.

**AND WHEREAS,** by seeing website the institution has submitted written representation on 07/08/2012.

NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Southern Regional Committee, NCTE hereby grants recognition to Sri Vivekananda College of Elementary Education, 590/1, 591/1/2, Edulapussapally Road, Mahabubabad, Warangal, Andhra Pradesh for conducting D.Ed Course of Two years duration with an annual intake of 50 students from the academic session 2012-2013 under clause 7(11) of NCTE (Recognition Norms & Procedure) Regulations, 2009 subject, to fulfillment of the following conditions:

- The endowment fund of Rs.5 lakhs and reserve fund of Rs.3 lakhs kept in joint account with SRC, NCTE should be maintained always. Loan raising or mortgaging of FDRs shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- III. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE (Recognition Norms & Procedure) Regulations, 2009.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 2. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/ Body, the State Government etc, as applicable.

- 3. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.
- 4. The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:-

a Sanctioned programmes along with annual intake in the institution;

b Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph;

c Name of faculty members who left or joined during the last , quarter;

d Names of students admitted during the current session along with qualification, percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;

e Fee charged from students;

f Available Infrastructural facilities;

g Facilities added during the last quarter;

h Number of books in the library, journals subscribed to and additions, if any, in the last quarter;

The institution shall be free to post additional relevant information, if it so desires

- j Any wrong or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 5. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.
