tiny of the application submitted by the institution, the documents attached therewith, the affidavit submitted and the report received from VT and Videography, and the certificates received from the university, the Committee is satisfied that the applicant fulfils the requirements under the provisions of NCTE ACT, Rules and relevant Regulations including the Norms and Standards for the said teacher education programme such as instructional facilities, infrastructural facilities, financial resources, etc., for running the programme.

NOW THEREFORE, in exercise of the powers vested under Section14(3) (a) of the NCTE ACT, 1993, the Regional Committee, NCTE hereby grants recognition to Vivekananda D.Ed College Plot/Khasara No. 18/1, Ramayanakandrika Village, Madalavaripalem Post, office, Podili Taluk & City, Prakasam District-523240, Andhra Pradesh for conducting D.El.Ed-Al programme of two years duration with two units of 50 students each from the academic sessions 2016-2017 under Clause 7(16) of NCTE (Recognition Norms & Procedure) Regulations, 2014 subject to fulfillment of the following conditions:-
