- The institution shall make admission only after it obtains affiliation from the examining body in 111. terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations 2014.
- The institution shall ensure that the required number of academic staff duly approved by IV. affiliating body for conducting the course should always remain in position.
- 2. Further, the recognition is subject to fulfillment of all such other requirements as prescribed by other regulatory bodies like UGC, affiliating University / Body, the State Government etc, as applicable.
- 3. The institution shall submit to the Regional Committee a Self- Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 4.
