PREAMBLE :

The Kannada Nuthana Vidya Samsthe, Chikmagalur, Karnataka had submitted an application to the Southern Regional Committee of NCTE for grant of recognition to Sri Kottureshwara D.Ed College, Ajjampura Post, Terikere Taluk, Chikmagalur District-577543, Karnataka for D.Ed Course on 29.12.2003.

After considering the report of the visiting team as well as other relevant materials furnished by the applicant institution, had noted that the applicant institution does not fulfill the requirements and issued a notice on 12.11.2004 to the applicant institution under provisio to Section 14(3)(b) of the NCTE Act, 1993, thereby giving an opportunity to the said applicant institution to make a written representation in this behalf.

Further, applicant institution had submitted the written representation on 17.11.2004. The said representation was considered by the Regional Committee on 17-18 November, 2004 and the Committee decided to refuse recognition.

Accordingly, order of refusal was issued vide Ir.No.9659 dated.27.12.2004.

The applicant institution preferred appeal under Section 18 of NCTE Act, before NCTE, New Delhi. The Appellate Authority considering the appeal passed an order vide.F.No.89-9/2005-Appeal dated.29.04.2005 remanding back the case with direction that the case of institution may be reprocessed by causing inspection of institution.

The order of Appellate Authority was placed before SRC in its meeting held on 15<sup>th</sup> June, 2005. The Committee decided to cause re-inspection of the institution. Accordingly, a re-inspection of the institution was caused on 22.06.2005 The report of the inspection team and other materials submitted by the institution along with application was placed before SRC in its meeting held on 10<sup>th</sup> August, 2005. The Regional Committee observed that the institution has made satisfactory arrangements in respect of infrastructural and instructional facilities for starting D.Ed course and decided to permit the institution to start Elementary (D.Ed) course from the session 2005-06.

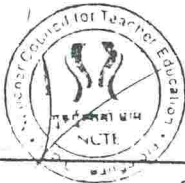

ORDER

2. On scrutiny of the application submitted by the institution, the documents attached therewith and the input received from the visiting team, the Committee has noted the following:
- The institution has acquired the land for setting up the teacher education institution.
  - The institution has constructed the building for conducting the course on the above mentioned land.
  - The institution has created an Endowment Fund of Rs.5 lakhs and a Reserve Fund of Rs. 2 lakhs.
  - The institution has selected the **Principal and five** lecturers for the said course.
3. Now, therefore, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Southern Regional Committee hereby grants recognition to **Sri Kottureshwara D.Ed College, Ajjampura Post, Terikere Taluk, Chikmagalur District-577543, Karnataka for Elementary (D.Ed) course of two and half years** duration from the academic session 2005-2006 with an annual intake of **50** students subject to fulfillment of the following.
- The institution will ensure that **Principal and Five** faculty members duly approved by the Director, DSERT, Bangalore are in position for an intake of **50** students before commencement of admissions and a copy of approved staff list shall be sent to the Southern Regional Committee immediately and in any case before commencement of the admissions.
  - The institution shall, within three months of the receipt of recognition order, convert the Endowment fund account into a joint account to be operated along with an official of the Southern Regional Committee.
  - The institution shall shift to its own premises / building within three years from the date of recognition. (in case the course is started in rented premises)
  - The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations.

4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like the State Government etc.
5. The institution shall submit to the Regional Committee a Performance Appraisal Report at the end of each academic year along with a copy of the approval of the Directorate of State Educational Research and Training (DSERT) to the appointment of faculty members, and the statement of annual accounts duly audited by a Chartered Accountant.
6. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued thereunder, the Regional Committee may withdraw the recognition under the Provisions of Section 17(1) of the NCTE Act, 1993.
