PREAMBLE :

The **Sri Rangapoopathi Educational Charitable Trust, Villupuram District, Tamilnadu** had submitted an application to the Southern Regional Committee of NCTE for grant of recognition to **Sri Rangapoopathi Teacher Training Institute for Women, Alampoondi Village, Gingee Taluk, Tindivanam District, Tamilnadu** for D.T.Ed Course on 26.12.2005.

After considering the report of the visiting team as well as other relevant materials furnished by the applicant institution, had noted that the applicant institution does not fulfill the requirements and issued a notice on **31.03.2007** to the applicant institution under provisio to Section 14(3)(b) of the NCTE Act, 1993, thereby giving an opportunity to the said applicant institution to make a written representation in this behalf.

Further, applicant institution had submitted the written representation on **16.04.2007**. The said representation was considered by the Regional Committee on 134th Meeting of SRC held on 29-31 May, 2007. and the Committee decided to refuse recognition.

Accordingly, order of refusal was issued vide Ir.No.4212 dated. 15.06.2007.

The applicant institution preferred appeal under Section 18 of NCTE Act, before NCTE, New Delhi. The Appellate Authority considering the appeal passed an order vide.F.No.89-96/2007 dated. 07.09.2007 reversing the decision of SRC.

The NCTE Headquarters Vide Letter dated 13.09.2007 directed this office to issue the recognition orders to the institution wherever reversal of decision is there and place the decision before SRC Subsequently. Accordingly, Conditional Recognition letter was issued to the institution on 18.09.2007. The institution has submitted reply with necessary annexures and staff profile.

Hence the order.

**ORDER**

WHEREAS in terms of Section 14(1) of the NCTE Act, 1993 **Sri Rangapoopathi Educational Charitable Trust, Villupuram District, Tamilnadu** has submitted an application to the Southern Regional Committee of NCTE for grant of recognition to **Sri Rangapoopathi Teacher Training Institute for Women, Alampoondi Village, Gingee Taluk, Tindivanam District, Tamilnadu** for **Elementary(D.T.Ed)** course of two years duration with an annual intake of **50 (Fifty)** Students.

2. AND WHEREAS on scrutiny of the application submitted by the institution, the documents attached therewith the affidavit and the input received from the visiting team in the form of report and videography, the Committee is satisfied that the institution fulfills the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the said teacher education programme such as instructional facilities, infrastructural facilities, library, accommodation, financial resources, laboratories etc for running the programme and has appointed duly qualified teaching staff as per NCTE norms.
3. Now, therefore, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Southern Regional Committee hereby grants recognition to **Sri Rangapoopathi Teacher Training Institute for Women, Alampoondi Village, Gingee Taluk, Tindivanam District, Tamilnadu** for conducting **Elementary(D.T.Ed)** course of two years duration with an annual intake of **50(Fifty)** students under clause 7(12) of Regulations dated.13.01.2006. This order of recognition shall be prospective and take effect from the date of issue of this order, subject to fulfillment of the following:
  - i) The institution shall, within one month of the receipt of recognition order, convert the endowment fund account into a joint account to be operated along with an official of the Southern Regional Committee.
  - ii) The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
  - iii) The institution shall shift to its own premises / building within three years from the date of recognition. (in case the course is started in rented premises)
  - iv) The institution will ensure that **Principal and Five** faculty members duly approved by DTERT, Chennai are in position for an intake of **50** students before commencement of the course and a report to this effect shall be sent to the Southern Regional Committee immediately.
6. 4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University / bodies, State Government etc, as applicable.
7. The institution shall make admissions only after it obtains affiliation from the examining body.
6. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.
7. The institution shall maintain & update the Web-site as per provisions of NCTE Regulations.



8. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition under the provisions of Section 17(1) of the NCTE Act.
