Preamble:

Renuka College of Diploma Education, Ramanagara, Kudligi Road, Hagaribommanahalli Taluk, Bellary – 583212, Karnataka (APS03844) has been granted recognition from the session 2005-2006 with an intake of 50 students vide order dated 03.02.2006.

The institution in its letter submitted on 28.05.2010 has requested for change of society as per the directions of the Hon'ble High Court, Dharwad as per the judgement dated 08.03.2010 in W.P. 61250 of 2010 from Sri. Ranganathaswamy Vidya Samsthe, Bapuji Public School, N.H.13, Chitradurga to Yedeyuryu Sri.Siddalingeshwara Vidya Peetha, Renuka Vidya Mandira, Kudligi Road, Ramanagara, Hagaribommanahalli — 583212, Bellary District, Karnataka.

The SRC in its 194th meeting held on 21-22 July 2010 considered the matter and decided to call for clarification from the institution. Accordingly Clarification letter was issued to the institution on 02.09.2010. The institution has submitted written representation on 28.09.2010 and has stated that the management has sought only for change the society but not shifting the college and its name. The institution has further stated that the college is existing at the same location with building, staff and its name. The NCTE Regulations 2009 does not provide for change of management.

The SRC in its 198th meeting held on 24-26 November, 2010 considered the request of the management and decided to permit the change of society from "Sri Ranganatha Swamy Vidya Samsthe" to "Yedeyuru Sri Siddalingeshwara Vidya Peetha", Renuka Vidya Mandira, Kudligi Road, Ramanagara, Hagaribommanahalli – 583212, Bellary District, Karnataka, subject to the condition that there is no change in location, name of the college etc., Further, the committee decided that change in Society name is permitted subject to payment of Rs. 40000/-. The institution has submitted Rs.40,000/-vide DD No.184911 dated.02.02.2011.

The matter was placed before SRC in its 203rd meeting held on 31st March 2011 and 1st April 2011 for review of its decision in view of NCTE regulations 2009 which does not provide for change of management.

SRC in its 205th meeting held on 18-19 May 2011 decided to re-confirm the decision earlier taken in SRCs 203rd meeting held on 31st March 2011 and 1st April 2011 which states as under:
