WHEREAS, Pragathi Convent Society, Ananthapur District, Andhra Pradesh made an application in the name and style of Sri Sreenivasa Teacher Training College, GIC Colony, Penukonda Mandal, Divisional Head Quarters, Ananthpur District-515110, Andhra Pradesh to SRC NCTE for establishment of D.EI.Ed course on 26.12.2006.

AND WHEREAS, the application was processed and the deficiency letter was issued. On fulfillment of all the required documents the inspection of the institution was conducted on 31.08.2007.

AND WHEREAS, the SRC in its 145th meeting held on 16th-18th October, 2007 after considering the report of the visiting team as well as other relevant materials furnished by applicant institution was satisfied that the applicant institution did not fulfill the requirements and issue a Notice on 31.10.2007 under provision to Section 14 (3)(b) of the NCTE Act, 1993, thereby giving an opportunity to the said institution to make a written representation for the following:

- The details of built-up space to be submitted
- The room wise space available for D.T.Ed course apart from existing course to be furnished

AND WHEREAS, the institution submitted its reply for Notice on 06.11.2007. The same was placed before SRC in its 149th meeting of SRC held on 13th -14th December, 2007 which came to conclusion that recognition/permission to the said institution be refused for the following reasons:

- The built-up space is not adequate.
- The room wise space available for D.Ed course is not adequate to run D.Ed course.

AND WHEREAS, a Refusal Order was issued to the institution on 04.01.2008. Aggrieved by the Refusal Order of SRC, the institution preferred an appeal before NCTE-Hqrs. The appellate authority vide its order dated 10.07.2008 confirmed the order of SRC appealed against.

AND WHEREAS, the institution filed a W.P.No.20129 of 2008 before the Hon'ble High Court of Judicature at Andhra Pradesh. A judgment copy was received from the Hon,ble High Court on 25.06.2009. The same was forwarded on 30.06.2009 to the Member Secretary seeking necessary advice in the matter.

AND WHEREAS, the Hon'ble High Court passed an order on 23.03.2011 in W.P.No. 24870 of 2010 reads as hereunder:

"Pending further orders, respondents are directed to conduct fresh inspection of the second petitioner college and consider for grant of recognition to the college to impart the education in D.Ed programme".

AND WHEREAS, this office had not received either W.P.24870/10 or the WP MP filed therein. Therefore counsel at Hyderabad was requested to obtain copies of the same and to examine whether the interim order can be challenged using judgment by Hon'ble High Court at Delhi in W.P.(C) No. 128/11dt.11.1.2011 in Shree Sitheshwar Education Trust Vs. NCTE.

AND WHEREAS, SRC in its 204th meeting held on 27th-28th, April, 2011 considered the Hon'ble High Court order dated 23.03.2011 for considering the recognition of the institution after re-inspecting the institution on payment of Rs. 40000/-. As per the decision of SRC, re-inspection was conducted on 08.06.2011.

AND WHEREAS, the SRC in its 207th meeting held on 21st-23rd June 2011, decided to arrange to file an Appeal against the orders of Hon'ble High Court of Hyderabad immediately and also to arrange for getting the judgment stayed without waiting for confirmation of minutes.

AND WHEREAS, as per direction of SRC a letter was issued to Legal Counsel on 18.07.2011 with request to file an appeal and inform of the development of the case at the earliest date. In response, in Legal Counsel vide letter dt. 06.08.2011 suggested as under:

"with reference to above subject writ petition the Hon'ble High court has passed interim order to conduct inspection of the petitioner institution and SRC compiled with the same by inspecting the petitioner college premises, hence no appeal is required in this regard".

AND WHEREAS, the legal counsel at Hyderabad informed that petitioner filed a writ petition. The office of SRC informed that the matter will be placed before SRC for decision/direction and the legal counsel placed the same fore Hon'ble High Court of Hyderabad.

AND WHEREAS, the SRC in its 211th meeting held on 21st-23rd, September, 2011 considered the VT Report, VCD and all the relevant documentary evidences and decided to serve Show Cause Notice under Section 17 of NCTE Act for the following:

- 1. The building completion certificate from competent Govt. authorized engineer is not submitted.
- 2. Language learning lab is not available.

AND WHEREAS, as per direction of SRC, Show Cause Notice was issued to the applicant institution on 27.10.2011, the institution submitted reply vide letter dated 01.11.2011.

AND WHEREAS, the SRC in its 213th meeting held on 6^{th} -7th, November, 2011 considered the reply of the institution dt. 01.11.2011 and since all formalities have been completed, came to the conclusion that the case arose on original application filed in 2006. Pre-2009 Regulations will appear, decided to Issue LOI under section 7 (9) to this institution.

AND WHEREAS, on careful perusal of the original file of the institution, court order dt. 13.07.2010 and other related documents, Act of NCTE, 1993, Regulations and guidelines of NCTE published from time to time laid on the table, the Regional Committee decided to issue Letter of Intent for grant of recognition to D.Ed course of two year duration with an annual intake of 50(Fifty only)(one unit) for the academic year 2012-13 subject to the appointment of qualified staff through duly constituted selection committee as per the Norms of NCTE/State Government/Affiliating University and be given effect before the commencement of the academic session.

AND WHEREAS, as per direction of Southern Regional Committee in its meeting, 213th meeting letter of intent prior to recognition was issued to applicant institution on 29.11.2011, In response to this office letter the institution submitted reply vide letter dt.30.01.2011.

AND WHEREAS, on careful perusal from the original file of the institution and approved staff profiles from the affiliating university/ body, submitted by the institution in response to the letter of intent, the SRC in its 217th meeting held on 08th-09th February, 2012 decided that Formal Recognition be granted for D.El.Ed (APS7890)course of two years duration with an annual intake of 50 (fifty only) students for the session 2012-13 subject to the rectification of deficiencies in staff list, if any.

NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Southern Regional Committee, NCTE hereby grants recognition to Sri Sreenivasa Teacher Training College, GIC Colony, Penukonda Mandal, Divisional Head Quarters, Ananthpur District-515110, Andhra Pradesh for conducting D.EI.Ed Course of two years duration from the academic session <u>2012-2013</u> under clause 7(11) of NCTE (Recognition Norms & Procedure) with intake of 50(Fifty only)(one unit) Regulations, 2009 subject, to fulfillment of the following conditions:

- 1. The endowment fund of Rs.5 lakhs and reserve fund of Rs.3 lakhs kept in joint account with SRC, NCTE should be maintained always. Loan raising or mortgaging of FDRs shall not be done.
- 2. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- 3. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE (Recognition Norms & Procedure) Regulations, 2009.
- 4. The institution shall ensure that the required number of academic staff for conducting the course is always in position.

Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/ Body, the State Government etc, as applicable.

The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.
