ORDER

WHEREAS, St. Anthony's Educational Society, D.No. 12-20-4/37, Prakash Nagar, Narasaraopet- 522 601, Guntur, Andhra Pradesh had submitted an application for grant of recognition to St. Mark NTR Institute of Elementary Teacher Education, Krishnaveni Campus, Pedda Cheruvu, Narasaraopet, Guntur Dist-522601, Andhra Pradesh for D.Ed Course.

AND WHEREAS, the file was under process and in the meanwhile, in view of the recommendations of the State Government of Andhra Pradesh vide letter dated 07.01.2009 not to further recognize/permit the institutions for conducting B.Ed, D.Ed, Physical Education, Language Pandit course(s), to this effect it was decided that application for B.Ed, D.Ed, Physical Education, Language Pandit courses from the States of Andhra Pradesh will not be considered for the academic session 2009-2010 and all such applications shall be returned along with processing fees and documents.

AND WHEREAS, the SRC in its 169th meeting held on 12-13th January, 2009 having considered the letter dated 7.1.2009 of State Government of Andhra Pradesh decided to give effect to the above decision of State Government of Andhra Pradesh as such, with immediate effect.

AND WHEREAS, further, a letter dated 07.02.2009 forwarded by Principal Secretary of Education requesting not to accord further recognition/permission to the new colleges/private B.Ed., D.Ed., Physical Education, Language Pandit in the state of Andhra Pradesh as the above colleges are exceeding in numbers than required.

AND WHEREAS, meanwhile, a letter dated 17.03.2009 has been received from NCTE Hqrs informing that the:-

"The recommendations of the Govt. of Andhra Pradesh not to grant recognition/ permission in respect of other courses like B.Ed , D.Ed and Physical Education courses have further been considered in NCTE and it has been decided that no further recognition/Permission to any institution in the state of Andhra Pradesh be considered by SRC for the academic session 2009-10 for B.Ed , D.Ed and physical Education Courses also".

AND WHEREAS, further, the state Government vide its letter dated 20.03.2009 informed that it has been decided not to recommend the name of this institution. The letters dated 07.01.2009, 07.02.2009, 17.03.2009 and 20.03.2009 were considered by SRC in its 172nd meeting held on 25th-26th March 2009 and SRC decided to accept the recommendation of the State Government of Andhra Pradesh, not to grant recognition to any of the Teacher Training Institutions in the state of Andhra Pradesh for the year 2009-10 and decided to close the applications. Accordingly as per the decision of SRC the application was closed on 29.04.2009.

AND WHEREAS, the Hon'ble High Court has passed an order .dt.23.04.2010 in WP.MP No. 12082 of 2010 in W.P.No.9360 of 2010 to consider the application of the petitioner without making reference to the recommendation of State Government policy dated 07.01.2009.

AND WHEREAS, the Southern Regional Committee in its 193rd Meeting held on 21st-23rd June 2010 considered the matter and decided to process the application.

As per decision of Regional Committee the file has been processed and deficiency letter was issued on 17.08.2010. The institution is having land and building on a lease of 30 years as per Rgulation 2006. As per questionnaire submitted by institution on 28.09.2010 it is having land on ownership in Sr. NO. 522/2- total 1 Acres and the building is constructed on it.

AND WHEREAS, as per affidavit dated 03 04.07 it is showing that it has permanent land in Sy. No. 48, 60, 61 of Kesanupalli, Village, Narasaraopet Mandal, Guntur District to extent of 2.23 hectares. The sale Deed dated 24.12.2005 states that the institution is having land of one acre in Southern Regional Committee. NO. 48, 60, 61 in Kesanupalli Village, Narasaraopet Mandal, Guntur, Andhra Pradesh

AND WHEREAS, SRC in its 201st meeting held on 22nd-23rd February, 2011 considered the matter and decided to cause inspection. Accordingly inspection was conducted on 29.03.2011.

AND WHEREAS, the Southern Regional Committee in its 204th Meeting held on 27th and 28th April 2011 considered the VT Report, VCD and all the relevant documentary evidences and it was decided to serve Show cause Notice for the following:

- The application submitted for grant of recognition to D.Ed course by the institution on 30.12.2005, whereas the land document submitted by the institution on lease basis registered on 30.09.2008. This is not permissible as per NCTE norms. As per the norms, the management should have owned the land even at the time of application.
- Non- Encumbrance Certificate from the competent Government Authorised person / Authority is to be submitted

AND WHEREAS, as per direction of SRC, SCN issued on 26.05.2011. In response to this Show Cause Notice the institution has submitted reply vide letter dated 01.06.2011, explaining and clarifying the points raised in the show cause notice. The Southern Regional Committee in its 208th Meeting held on 13th and 14th July 2011 considered the reply of the institution dated 01.06.2011, and decided to issue <u>letter of intent</u> prior to grant of recognition under clause 7(9) of the NCTE regulation, for grant of recognition. Accordingly as per direction of SRC LOI was issued to the applicant institution on 20/07/2011.

AND WHEREAS, in response to LOI the institution has submitted reply vide letter dated 21.09.2011. SRC in its 212th Meeting held on 24th October 2011 considered the reply and decided to issue Formal Recognition.

NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Southern Regional Committee, NCTE hereby grants recognition to St. Mark NTR Institute of Elementary Teacher Education, Krishnaveni Campus, Pedda Cheru, Narasaraopet, Guntur Dist-522601, Andhra Pradesh for conducting D.Ed Course of two year duration with an annual intake of 50 (Fifty) students from the academic session 2012-2013 under clause 7(11) of NCTE (Recognition Norms & Procedure) Regulations, 2009 subject, to fulfillment of the following conditions:

- i The endowment fund of Rs.5 lakhs and reserve fund of Rs.3 lakhs kept in joint account with SRC, NCTE should be maintained always. Loan raising or mortgaging of FDRs shall not be done.
- The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.

The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE (Recognition Norms & Procedure) Regulations, 2009.

iv The institution shall ensure that the required number of academic staff for conducting the course is always in position.

Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/ Body, the State Government etc, as applicable.

The institution shall submit to the Regional Committee a Solf-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.

The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:-

- 1) Copy of the Application Form
- 2) Land and Building Particulars
- 3) Staff Profile
- 4) Recognition letter
- 5) Information for having fulfilled the norms & standard and other required conditions.

If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.
