WHEREAS, Massianic Educational Society, Raja Veedhi, Gadwal-509125, Mahabubnagar District, Telangana had submitted an application to the Southern Regional Committee of NCTE of seeking permission to start St. Thomas College of Elementary Education, No. 3-1-37, , Raja Veedhi, Gadwal -509125, Mahabubnagar District, Telangana for Elementary (D.Ed) course of two years duration from the academic session 2005-06.

AND WHEREAS, the recognition was granted to the institution on 26.08.2015 with an intake of 50 students with a condition that the institution shall shift both B.Ed and D.Ed courses to own premises /building within three years from the date of recognition of B.Ed college as the recognition for D.Ed is issued based on existence of B.Ed college and notification dated 01.01.2014 of NCTE. (in case the B.Ed/ D.Ed courses is started in rented premises).

AND WHEREAS, on 25.03.2015, a letter was received from the Director of School Education, Telangana, Hyderabad regarding grant of renewal of temporary provisional affiliation for the year 2014-15 in respect of certain private Diploma in elementary Teacher Education institution including St. Thomas College of Elementary Education, No. 3-1-37, Raja Veedhi, Gadwal-509125, Mahabubnagar District, Telangana (D.Ed and B.Ed) in Telangana State.

AND WHEREAS, the SRC in its 289<sup>th</sup> meeting held on 23<sup>rd</sup> June, 2015 considered letter dated 16.03.2015 from Director of School Education, Govt. of Telangana, Hyderabad, in respect of certain private Diploma In Elementary Teacher Education (43 colleges) not fulfilling the deficiencies and decided to issue show cause notice for "withdrawal of recognition citing the deficiencies listed by the affiliating body."

AND WHEREAS, show cause notice with a copy to SCERT was issued on 16.09.2015 for the following deficiency:

- Land is 2906 Sq. Mtrs instead of 3000 Sq.Mts and discrebancy in location of the site with reference to NCTE order.

AND WHEREAS, the institution has submitted its written representation on 29.09.2015 along with relevant documents.

AND WHEREAS, the SRC in its 294<sup>th</sup> meeting held on 14<sup>th</sup>, 15<sup>th</sup>, 16<sup>th</sup>, November, 2015 considered the matter and it has decided as under:

1. This is a composite institution offering B.Ed and D.El.Ed
2. Resubmit along with documents submitted for the second unit of B.Ed.

AND WHEREAS, in the meantime, the institution has submitted its written representation along with documents on 16.11.2015 and stating as follows:

"... I would like submit that the Director SCERT, Hyderabad. T.S has given show cause notice through the letter cited under 1<sup>st</sup> reference asking to get clearance from your good office in connection of these to deficiencies.

1. During the year 2014-15 conditional affiliation granted to rectify Land is 2906 Sq.Mts instead of 3000 Sq.Mts.
2. Discrebancy in location of the site with reference to NCTE.

In this connection I would like to submit that the 1<sup>st</sup> deficiency is rectified by the management by constructing remaining area and toilets for boys & staff (Men) with size of 5\*5 mtrs. So the total constructed area is 1521.28 Sq.Mts. The same was admitted in the show cause notice issued by the Director SCERT in the show cause notice letter cited 2<sup>nd</sup> reference. But, said that no necessary documents are produced by the management inspite of submission of all required documents i.e. Building Completion Certificate issued by Asst. Engineer, (PR), M.P Gadwal. Dt: 18.09.2015. The same was all so informed to your good office though this office letter cited under 3<sup>rd</sup> reference.

Regarding discrebancy in location of the site of D.Ed College has very clearly mentioned the regions o deficiencies to the Director SCERT, Hyd T.S the same explanation was submitted to your good office through this office letter cited under 3<sup>rd</sup> reference.

However I would like to once again, submit the region for the discebancy. A already explain, at the time of applying for recognition to new B.Ed Colleges, i.e St.Thomas College of Teacher Education, Gadwal the management purchased land in Putanpally in the year 2001. At the time of construction of building was just under progress. So the management gave the address of Education Society i.e, Messianic Educational Society Gadwal which was registered in the year 1996. The societ address H. No. 3-1-37, Rajaveedhi, Gadwal for correspondence with the same address the college accorded recognition. But the college is running in putapally where the building was constructed. After that application for D.Ed College was submitted with the same address for correspondence Purpose. So I sincerely submit that B.Ed & D.Ed colleges are running in Putanpally of Pudur sivar from their inception. I am herewith submitting the following documents that were already submitted to the Director SCERT, TS, Hyd as a proof.

- The documents produced are adequate. Accept them and closes the case. Inform affiliating body.

AND WHEREAS, the institution has submitted its written representation on 16.03.2016, request for the issue of clearance letter changing the address of the college.
