ORDER

**WHEREAS, St.Mary's Education Society, Jangaon, Warrangal District, Andhra Pradesh** had submitted an application to the Southern Regional Committee of NCTE seeking permission to start **St. Mary's Elementary Teacher Training Institute, H.No.6-2-7/1-1, Hyderabad Road, Jangaon, Warrangal District - 506167, Andhra Pradesh** for Elementary (D.Ed) course of two years duration from the academic session 2005-2006 with an annual intake of 50 students and was granted recognition on **04.08.2005**.

**AND WHEREAS, on 27.11.2014, this office has received copy of PROCEEDINGS OF THE DIRECTOR, S.C.E.R.T., T.S, HYDERABAD Rc.No.275/(SCERTAP)/A/TE/TSCERT/2011 dated 22/11/2014 regarding verification of staff lists for D.Ed course in respect of St. Mary's Elementary Teacher Training Institute, H.No.6-2-7/11,Hyderabad Road, Jangaon, Warrangal-506167, Andhra Pradesh. An approved staff list-Tentative is enclosed as Annexure-I.**

**AND WHEREAS, the Southern Regional Committee in its 278<sup>th</sup> meeting held during 25<sup>th</sup> January 2015, considered the matter, proceedings of the Director, SCERT, Telangana State, regarding the staff list, and it was decided to serve Notice Under NCTE Act.**

**AND WHEREAS, as per the decision of SRC a Show Cause Notice was issued to the institution on 27.02.2015. The institution has submitted a written representation to the Show Cause Notice 19.03.2015.**

**AND WHEREAS, the appointment of the Principal Selection considered under the guide lines of Two (2) years minimum experience as per the G.O. Ms. No. 92 (EDUCATION(SE-TRG) DEPARTMENT Dated 06.11.2007 of Government of Andhra Pradesh by the Director, SCERT-AP, Hyderabad, therefore I, request you to kindly examine the documents to consider our representation to continue recognition of this Institution.**

**AND WHEREAS, the SRC in its 285<sup>th</sup> meeting held on 17<sup>th</sup> April, 2015, considered the written reply of the institution on the above matter and also the relevant documents of the institution and decided to withdraw recognition for the following reasons:-**

1. "Even after the SCERT certificate, the Principal is seen to fall short of the 5-year experience prescribed by the NCTE Regulations.
2. Based on the above points the committee decides to withdraw the recognition of the D.Ed (APS02554) course run by the St. Mary's Elementary Teacher Training Institute, Warrangal, Andhra Pradesh from the year 2015-16, in order to enable the ongoing batch of students in D.Ed, course, if any, to complete their course.

**AND WHEREAS, on 05.05.2015, a letter dated 29.04.2015 is received by this office from the Correspondent, St. Mary's Elementary Teacher Training Institute, Jangaon, Warangal District-506167, Telangana State stated as under:-**

" In constitution of our reply in the reference 3<sup>rd</sup> cited (Our letter No, SMTTC/106/2015, dated: 14.03.2015 addressed to the RD, NCTE, SRC, Bangalore) we wish to further submit that, the Director, SCERT, TS, Hyderabad in the reference 1<sup>st</sup> cited( Proc.RC.No. 275/(SCERTAP)/A/TE/TSCERT/2011, dated:22.11.2014 of the Director, S.C.E.R.T., T.S., Hyderabad) has approved the names of (5) fresh recruited staff members, while quoting (3) staff member names, whose name were approved on 14.11.2011 by the Director, SCERT, AP prior re-organization of Andhra Pradesh. In the said order dated: 22.11.2014 admitting the experience of the Principal in terms of the G.O.Ms.No.92 Education (SE.TRG) Department, dated: 06.11.2007, as on the date 14.11.2011 has shown as "4 years in the Elementary Teacher Education Institutions". The Director, SCERT, TS ought to have mentioned the experience adding the subsequent period from 14.11.2011 till 22.11.2014 in respect of the said Principal as " 7 years 8 months in the Elementary Teacher Education Institutions'. It is fact that the said Principal (Sri B. Narasimha Chary) is being reading his services in this institution from the date of approval of his name w.e.f 14.11.2011. He is

having more than seven years of experience as requisite in terms of the NCTE Norms in vogue as on the date of issue of the said order dated:22.11.2014 by the Director, SCERT, TS, and Hyderabad.

In this context, I submit that our institution is being running with qualified and experiences faculty in terms of the rules in vogue. Hence the question as raised in the reference 2<sup>nd</sup> cited(Show Cause Notice No.APS02554/D.Ed/AP/2015, Dated:27.02.2015 of the Regional Director, SRC, NCTE, Bangalore), is not at all holds good.

Further it is noticed that the SRC, NCTE, Bangalore has resolved to with draw the recognition of out D.Ed programme from the academic year 2015-2016 in the reference 4<sup>th</sup> cited( Minutes dated: 17.04.2015, of the SRC, NCTE in the meeting No, 285).

Therefore, we request you to kindly to drop the adverse action on the institution on above said grounds and we will agrange to submit the rectified order of staff approval of Director, SCERT, TS in due course."

**AND WHEREAS**, on 25.05.2015, a letter received by this office from the institution requesting to consider the experience of the Principal and restore the recognition of the institution.

**AND WHEREAS**, the SRC in its 291<sup>st</sup> meeting held on 20<sup>th</sup> & 21<sup>st</sup> August, 2015 considered the matter and it has decided that, 1. Since the Principal has by now acquired 7 years experience, we may accept the staff list as given. 2. Restore Recognition. 3. Cause inspection after 31<sup>st</sup> Oct, 2015 to ensure full compliance of 2014 Regulations.

**NOW THEREFORE**, recognition accorded to **St. Mary's Elementary Teacher Training Institute, H.No.6-2-7/1-1, Hyderabad Road, Jangaon, Warrangal District - 506167, Andhra Pradesh** for D.Ed course is hereby restored/continued till further orders.

Further, in view of the fact that NCTE Regulations (Recognition, Norms and Standards) 2014 are notified, the institution is required to conform to the new requirements as prescribed in NCTE Regulations (Regulation, Norms and Standards), 2014 and submit compliance before 30.10.2015.

If the institution contravenes any of the conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.

Also order that a copy of this order be published in the Official Gazette.
