ORDER

Preamble:-

WHEREAS, Sai Baba Educational Society, Plot No.56/223, Akkayapalli Road, Kadapa Village and Post & Taluk, Kadapa District-516 003, Andhra Pradesh has applied for grant of recognition to Sai Baba DIET College, Khasara/Plot No.43/1, Akkayapalli Street, Kadapa Village, Post & Taluk, Kadapa District-516002, Andhra Pradesh for starting D.Ed course of two years duration and section 14(l) of NCTE Act, 1993 to the SRC, NCTE online on 29.09.2011 and physical application has been received in the office of SRC on 03.10.2011.

AND WHEREAS, recognition order was issued vide order F.No.SRCAPP1238/D.El.Ed/AP/2013-14/51428 dated 6.5.2013 for D.El.Ed course with an intake of 50 students from the academic session 2014-15 as per Supreme Court Order dated 13.12.2012 filed by Maa Vaishno Devi Mahila Maha Vidyalaya.


