ORDER**

WHEREAS, Sri Sai Venkatadri Educational Society, Karimnagar District, Telangana had submitted an application to the SRC-NCTE for grant of recognition to Sangamitra College of Education, H.No.11-56/1/1/B, Beside Andhra Bank, Akkannapet Road, Village & Mandal, Husnabad, Karimnagar District-505467, Telangana for B.Ed course of one year duration with an annual intake of 100 students. The recognition was granted to the institution on 22.09.2008.

AND WHEREAS, on 31.12.2014, letters were issued to all existing institutions regarding notification of new Regulations, 2014 seeking consent on their willingness for fulfilling the revised norms and standards before 31.10.2015.

AND WHEREAS, the institution submitted the affidavit for offering B.Ed course with an intake of 100 students, on 27.01.2015.

AND WHEREAS, the SRC in its 276th meeting held on 7th-9th January, 2015 decided to issue provisional recognition orders to the existing institutions and the Committee also decided to maintain a check list of such cases for verification in October/November and for causing inspection.

AND WHEREAS, revised recognition order was issued to the institution on 18.03.2015 for two units of 50 students each with mention that the institution has not shifted to its own premises as stipulated in its Formal Recognition order.

AND WHEREAS, the institution submitted written representation on 29.02.2016 along with documents.

AND WHEREAS, the SRC in its 314th meeting held on 27th to 28th May 2016. The Committee considered the matter and decided as under:

For cases of B.Ed (2 Units) in the existing institution, where RPRO, has been issued, we have to cause inspection to check adherence to the 2014 Regulations. This action will have to be completed by July 2016 so that revised Formal Recognition can be issued w.e.f. 2016-17 to enable them to make admission in time.

Action to check the documents in these cases (about 1885 in number) will take time. Instead of Waiting for that action to be completed for placing them before the SRC, to save time, VT Inspections can straightaway be ordered. VT Inspection Report can be considered along with examination of the documents.

Regional Director is authorized to initiate action accordingly. The institution concerned may be alerted about such action so that they will be prepared to receive the Visiting Teams. They may also be advised to keep in readiness latest approved Faculty Lists for Submission to the VTs.

AND WHEREAS, as per the decision of SRC, Inspection intimation was sent to the institution on 14.06.2016. The institution submitted its written representation along with shifting fee of Rs.1,50,000/- and documents on 13.07.2016.

AND WHEREAS, the documents were processed and placed before SRC in its 317th meeting held on 28th & 30th July, 2016. The Committee considered the matter and decided as under:

1. Title to lands is there. Land area is adequate.
2. EC/LUC are in order.
3. BP/BCC are in order. Built up area is shown to be adequate.
4. Original FDRs not given.
5. Faculty list not given.

6. Fee paid in full.

7.1. Cause Inspection

7.2. Ask VT to collect all relevant documents.

7.3. Ask VT to check in particular adequacy of facilities for B.Ed (2 units).

The SRC in its 319th meeting held on 30th & 31st August, 2016 considered the letter dated 16.07.2016 received from Prof. M. Komal Reddy, Registrar(FAC), Satavahana University and decided as under:

- If shifting cases are pending with us, the affiliating body can surely give interim affiliation.

AND WHEREAS, a letter was sent to the Registrar, Satavahana University on 15.09.2016.

AND WHEREAS, the inspection of the institution was conducted on 30.08.2016 and the VT report was received in the office on 08.09.2016 along with documents and a copy of faculty list.

AND WHEREAS, the SRC in its 321st meeting held on 28th & 29th September, 2016 considered the matter and decided to "**permit shifting for B.Ed (2 units).**"

NOW THEREFORE, permission is hereby granted to Sangamitra College of Education, H.No.11-56/1/1/B, Beside Andhra Bank, Akkannapet Road, Village & Mandal, Husnabad, Karimnagar District-505467, Telangana for shifting of premises from Sangamitra College of Education, H.No.11-56/1/1/B, Beside Andhra Bank, Akkannapet Road, Village & Mandal, Husnabad, Karimnagar District-505467, Telangana to Sangamitra College of Education, Plot No. 278, Akkannapet Street, Husnabad Village, Taluk & City, Husnabad, Karimnagar District – 505467, Telangana.

If the institution contravenes any of the conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.

Also order that a copy of this Order be published in the Official Gazette.
