ORDER

WHEREAS in terms of Section 14(1) of the NCTE Act, 1993 Shree Swaminarayana Gurukul Trust, Sy no. 223, Chevella Road, Enkapally Post, Moinabad Mandal, Ranga Reddy District, Hyderabad-500075, Andhra Pradesh had submitted an on-line application to the Southern Regional Committee of NCTE on 15.10.2008 for grant of recognition for D.Ed course of two year duration with an annual intake of 50 students at Shree Swamynarayan Gurukul College of Education, Chevella Road, Moinabad Mandal, Ranga Reddy District, Hyderabad-500075, Andhra Pradesh.

AND WHEREAS, the file was under process and in the meanwhile, in view of the recommendations of the State Government of Andhra Pradesh vide letter dated 07.01.2009 not to further recognize/permit the institutions for conducting B.Ed., D.Ed., Physical Education, Language Pandit course(s).

AND WHEREAS, the SRC in its 169th Meeting held on 12th-13th January, 2009 having considered the letter dated 07.01.2009 of State Government of Andhra Pradesh and decided to give effect to the decision of State Government of Andhra Pradesh as such, with immediate effect.

AND WHEREAS, a letter dated 07.02.2009 forwarded by Principal Secretary of Education requesting not to accord further recognition/permission to the new colleges/private 8.Ed., D.Ed., Physical Education, Language Pandit course(s), in the state of Andhra Pradesh as the above colleges are exceeding in numbers than required.

AND WREREAS, a letter dated 17th March, 2009 has been received from NCTE Hors informing that the "The recommendations of the Govt, of Andhra Pradesh not to grant recognition/permission in respect of other courses like B.Ed., D.Ed, Physical Education, Language Pandit course(s),have further been considered in NCTE and it has been decided that no further recognition/permission to any institution in the state of Andhra Pradesh be considered by SRC for the academic session 2009-10 for B.Ed., D.Ed., and Physical Education courses also.

AND WHEREAS, the state Government vide its letter dated 20.03.2009 informed that if has been decided not to recommend the name of your institution.

AND WHEREAS, the letter dated 07.01.2009, 07.02.2009, 17.03.2009 and 20.03.2009 was considered by SRC in its 172rd meeting heid on 25th-26th March 2009 and SRC decided to accept the recommendation of the State Government of Andhra Pradesh, not to grant recognition to any of the Teacher Institutions in the State of Andhra Pradesh for the year 2009-10 and decided to return the applications.

AND WHEREAS, the application submitted by Swaminarayan Curukul Trust Hyderabad, Andhra Pradesh here by closed. And in this regard a closure order was issued to applicant institution on 18.04.2009. 100-2

AND WHEREAS, the institution ignored to approach Appellate Authority, NCTE Head Quarters and directly approached Hon'ble High Court in writ petition no 5468/2011 wherein the Hon'ble High court passed an order as under:-

The approach of the state Government in denying recognition has been faulted and the impugned orders therein were set aside with a direction to the respondents therein to reconsider the applications of the petitioners therein with reference to the policy existed at the relevant point of time. A copy of similar order passed by this court in W.P. No 6712 of 2009, dated 16.12.2009 is placed before this court.

In view of the said representation, this Writ petition is allowed in terms of the order passed in W.P.No.6712 of 2009, dated 16.12.2009. There shall be no order to costs

Registry is directed to annex a copy of the order in W.P.No.6712 of 2009 dated 16.12 2009 to this order.

AND WHEREAS, and in this regard a letter was issued to applicant institution on 18.04.2009.

AND WHEREAS, the SRC in its 209th meeting held on 31st Juty 2011 considered the matter and decided to process the application—on submission of Rs. 40000/- towards inspection fee, original application, Land document, Building completion Certificate and other related supporting documents etc., within four weeks from the date of confirmation of the Minutes.

AND WHEREAS, as per direction of SRC a letter was sent to the institution on 25.05.2011 with request to submit reply. In response to this office letter dated 25.05.2011 the institution has submitted reply vide letter dated 07.06.2011.

AND WHEREAS, the SRC in its 209th Meeting of SRC held on 31st July, 2011 considered the reply of the institution dt. 07.06.2011 and all the relevant documentary evidences and decided to serve Show cause notice under section 17 of NCTE Act for the following:

- Original FDRs for Rs.5 facs and 3 lacs towards endowment and reserve fund respectively from a Nationalised Bank in joint account is to be submitted.
- Land usage certificate from the concerned Government authorities stating that the land is exclusively permitted/sanctioned for educational purpose only should be submitted
- 3. From the reply of the institution on Gift deed submitted, the land is in individual's name and not in the Name of the Society/Trust/Institution as per NCTE Norms. In the gift deed submitted by the institution land is in individual name of Sn Devi Prasad, M.D., Sri Swaminarayana Gurukui. The land and building have to be complete in all respects, on the date of application as per regulations.
- The building plan approved by competent Government authority is to be submitted.
- Non-Encumbrance certificate from the competent Government authorised person/authority to be submitted.

AND WHEREAS, accordingly, a show cause notice was issued to the institution on 12.10.2011. The institution has submitted its written representation on 09.11.2011.

AND WHEREAS, the SRC in its 215th meeting held on 12th-13th of December, 2011 considered the reply of the institution dt. 14.11.2011 and all the relevant documents by the institution and decided to cause inspection at the premises under section 17 of NCTE Act. On payment of Rs. 40000/- towards inspection fee, to examine whether the institution fulfills all the requirements as per the norms, to the condition that the deficiencies, if any, were duly certified by the institution, as per the norms. Accordingly, the inspection of the institution was conducted on 28.01.2012.

AND WHEREAS, the SRC in its 219th Meeting of SRC held on 15th–16th March, 2012 considered the VT report, VCD and all the relevant documentary evidences and it was decided to serve Show cause Notice under Section 17 of NCTE Act. Accordingly, a show cause notice was issued to the institution on 11.04.2012. The institution has submitted in its written representation on 01.05.2012 stated as follows:-

Twe are in receipt of your letter under reference on 19.04.2012 with some observations on D.Ed college. The action is in hand to rectify the observations and also we had taken up a case with legal opinion on Gift Deed with public lawyer of Govt. of Andhra Pradesh. In view of above, may we request you to kindly extent for 20 days time to submit the Para wise replies to the observations.

AND WHEREAS, mean while the institution submitted two written representation dt. 25,05,2012 and 19,07,2012.

AND WHEREAS, the SRC in its 228th meeting held on 24th-25th July, 2012 and decided to issue Letter of Intent for grant of recognition. Accordingly, LOI was issued to the institution on 31.07.2012. The institution had submitted written representation on 29.08.2012.

AND WHEREAS, the matter was placed before SRC in its 232nd meeting held on 29th-31st August, 2012 and SRC decided to issue Formal Recognition.

NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act. 1993, the Southern Regional Committee, NCTE hereby grants recognition to Shree Swamynarayan Gurukul College of Education, Chevella Road, Moinabad Mandal, Ranga Reddy District, Hyderabad-500075, Andhra Pradesh for conducting D.Ed Course of two year duration with an annual intake of 50 students from the academic session 2012-2013 under clause 7(11) of NCTE (Recognition Norms & Procedure) Regulations, 2009 subject, to fulfillment of the following conditions:

- The endowment fund of Rs.5 takhs and reserve fund of Rs.3 takhs kept in joint account with SRC, NCTE should be maintained always. Loan raising or mortgaging of FDRs shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- III. The institution shall make admission only after it obtains affillation from the examining body in terms of clause 8(12) of the NCTE (Recognition Norms & Procedure) Regulations, 2009.
- IV. The institution shall ensure that the required number of academic staff duty approved by affiliating body for conducting the course should always remain in position.
- Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affillating University/ Body, the State Government etc, as applicable.
- The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.
- The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:-
 - a) Sanctioned programmes along with annual intake in the institution;

b) Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph;

Name of faculty members who left or joined during the last, quarter;

d) Names of students admitted during the current session along with qualification, percentage of marks in the qualifying examination and in the entrance test, if any, date of admission,etc.

e) Fee charged from students;

Available infrastructural facilities:

g) Facilities added during the last quarier.

h) Number of books in the library, journals subscribed to and additions, if any, in the last

i) The institution shall be free to post additional relevant information, if it so desires.

- Any wrong or incomplete information on website shall render the institution liable for withdrawal of recognition
- 5. If the institution contravenes any of the above conditions or the provisions of the NOTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.
