AND WHEREAS, the institution has submitted shifting proposal along with documents a copy of Court case in W.P.No.39468 of 2014 the SRC considered same in its 276th meeting held during 7th to 9th July, 2015 and decided to cause inspection.

AND WHEREAS, the inspection of the institution was conducted on 18.01.2015 and the VT Report was received by this office on 19.01.2015

AND WHEREAS, on 20.01.2015, an e-mail was received from the advocate, Shri. Ramakanth Reddy stating as under :-

AND WHEREAS, accordingly, the VT reports were sent to the advocate, Shri. Ramakanth Reddy on 20.01.2015

AND WHEREAS, the visiting team reports placed before Southern Regional Committee in its 278th meeting held on 25th January, 2015 considered the matter, took note of the VT report dated 18.01.2015 and decided to await the Court order.

AND WHEREAS, as per regulation 2014, the institution has submitted affidavit and requested for revised order. Was issued to the institution on 01.07.2015

AND WHEREAS, a letter was addressed to the advocate, Shri. Ramakanth Reddy on 20/03/2015 seeking present status of the writ petition filed i.e W.P.No. 39468 of 2014.


AND WHEREAS, again the institution has submitted written representation on 29.05.2015 along with shifting fee Rs. 1,50,000/-

NOW THEREFORE, permission is hereby accorded by SRC to **Sri Lakshmi B.P.Ed College, Khasara No,268, P.Chinthakuntla Village, Allagadda Post & Taluk, Kurnool District-518543, Andhra Pradesh** to shift its premises to the new location / building at **Sri Lakshmi B.P.Ed College, Dupadu Village, Kallur Taluk, Kurnool District, Andhra Pradesh.**

If the institution contravenes any of the conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.
