Road, Ettivadi Village and Post, Polur Taluk, Tiruvannamalai District — 606907, Tamilnadu for conducting M.P.Ed programme of two years duration with an annual intake of 40 students (1 unit) from the academic sessions 2015-2016 under Clause 7(16) of NCTE (Recognition Norms & Procedure) Regulations, 2014 subject to fulfillment of the following conditions:-

- The Eridowment fund of Rs.5 lakhs and Reserve fund of Rs.7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Loan raising against or mortgaging of FDR's shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- III. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remaining position.

If the institution Contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under the institution will render itself vulnerable to adverse action including withdrawal of recognition by the regional committee under the provisions of Section17(1) of the NCTE Act.
