AND WHEREAS, the institution has submitted applications for D.El.Ed-AI and B.Ed courses for the year 2016-17. SRC, in its 302nd meeting held during 09th to 11th February, 2016, Considered the notice reply of the institution for new application & decided as under :

1. *The request for B.Ed and D.El.Ed-AI is at a location different from the one at which D.El.Ed is being run.*
2. *D.El.Ed-AI can not be considered in isolation.*
3. *In the absence of D.El.Ed and D.El.Ed-AI, B.Ed will become a stand-alone programme.*
4. *If D.El.Ed can be shifted from its present location to the new location, then there will be an acceptable 'base' and composite inspection can be conducted as requested.*
5. *Collect fee for the shifting inspection and cause composite inspection.*

AND WHEREAS, SRC, in its 305th meeting held during 25th to 27th February, 2016 considered end the VT report of new applications and existing D.El.Ed for shifting and decided as permit shifting to new premises.


