WHEREAS, in terms of Section 14(1) of the NCTE Act, 1993, Venkata Sai Educational Society, Mahabubnagar, Telangana had applied on 30.06.2006 for grant of recognition to Sri Sai Teja College of Education, H.No. 8-2-32/G-8, Teachers Colony, Mahabubnagar-509001, Telangana for B.Ed course of one year duration.

AND WHEREAS, the recognition was granted to the institution for B.Ed course of one year duration on 19.11.2007 with an intake of 100 students from the academic session **2007-08**.

AND WHEREAS, on 31.12.2014, letters were issued to all the existing institutions regarding notification of new Regulations, 2014 and seeking consent on their willingness for fulfilling the revised norms and standards before 31.10.2015. The institution submitted affidavit on 27.01.2015 for offering B.Ed course with an intake of two units of 100 students.

AND WHEREAS, the SRC in its 276th meeting held on 7th-9th January, 2015 decided to issue provisional recognition orders to the existing institutions which had submitted affidavit for compliance of NCTE Regulations, 2014.

AND WHEREAS, revised order was issued to the institution on 11.05.2015 with an intake of two units of 100 students, with the condition that the institution has not shifted to its own premises.

AND WHEREAS, the institution submitted representation on 26.08.2015 along with two DD of Rs. 1,50,000/- bearing No. 672561 dt. 30.07.2015 and relevant documents. The documents were processed and placed before SRC its 315th meeting held on 17th – 18th June 2016. The Committee considered the matter and decided to issue show cause notice for non-submission of documents.

AND WHEREAS, before issuance of show cause notice, the institution submitted representation on 04.07.2016 along with documents. The documents were processed and placed before SRC in its 317th meeting held on 28th -30th July, 2016. The Committee considered the matter and decided to cause inspection for B.Ed(2 units).

AND WHEREAS, as per the decision of SRC, names of VT were generated through online VT Module and the inspection of the institution was conducted on 10.09.2016 and VT report along with documents and CD received on 15.09.2016.

AND WHEREAS, the matter was placed before the SRC in its 321st meeting held on 28th - 29th September 2016. The Committee considered the matter and decided to issue permission for shifting and for issue of new FR for B.Ed (2 units) at the new address.

NOW THEREFORE, this order is issued granting permission to the institution, Sri Sai Teja College of Education, H.No. 8-2-32/G-8, Teachers Colony, Mahabubnagar-509001, Telangana for conducting B.Ed course of two years duration with an intake of 100 students (two units of 50 students each) from the academic session 2016-17 and also permission for change of premises of the institution from Sri Sai Teja College of Education, H.No. 8-2-32/G-8, Teachers Colony, Mahabubnagar-509001, Telangana to Sri Sai Teja College of Education, Sy. No. 500, 501/2, Sankalmaddi Village, Addakal Mandal, Mahabubnagar District-509380, Telangana for conducting B.Ed course of two years duration with an intake of 100 students (two units of 50 each) subject to fulfillment of the following conditions:

- I. The Endowment fund of Rs.5 lakhs and Reserve fund of Rs.7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014, as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 2. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University / Body, the State Government etc, as applicable.
- 3. The institution shall submit to the Regional Committee a Self- Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 4. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter –alia, the details of the institution, its location, name of the programme(s) with intake; availability of physical infrastructure, such as land, building, office, classrooms, and other facilities or amenities; instructional facilities, such as laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
 - a. Sanctioned programme(s) along with annual intake in the institution:
 - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - c. Name of faculty members who left or joined during the last, quarter:
 - d. Names of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.:
 - e. Fee charged from students;
 - f. Available infrastructural facilities:
 - g. Facilities added during the last quarter;
 - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
 - The affidavit with enclosure submitted along with application.
 - j. The institution shall be free to post additional relevant information, if it so desires.
 - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- **5.** The institution shall adhere to the mandatory disclosure in the prescribed format and display upto-date information on its official website.
- 6. The institution shall make available the list of students admitted on its official website.

7. The institution shall fill the information on GIS portal on the NCTE website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made or issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisions of Section17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
