- e Fee charged from students;
- f Available infrastructural facilities;
- g Facilities added during the last quarter;
- h Number of books in the library, journals subscribed to and additions, if any, in the last quarter;

The institution shall be free to post additional relevant information, if it so desires

- Any wrong or incomplete information on website shall render the institution liable for withdrawal of recognition
- 4. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.
