NOW THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Regional Committee, NCTE hereby grants recognition to Sri Vidhyodhaya College of Education, Plot/Khasara No.7/20, 7/21A, 7/21E, Street.No.7/20, Thirupachavadimedu village, Kondangi Post Office, Villupuram Taluk & District, Pin-605301, Tamilnadu for conducting B.Ed programme of two years duration with an annual intake of 100 students (two units) from the academic sessions 2015-2016 under Clause 7(1b) of NCTE (Recognition Norms & Procedure) Regulations, 2014 subject to fulfillment of the following conditions:-

- I. The Endowment fund of Rs 5 lakhs and Reserve fund of Rs 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Loan raising against or mortgaging of FDR's shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- III. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- V. The institution shall comply with the additional facilities required (additional builtup area, additional staff, additional funds etc) for the second unit as prescribed in NCTE (Recognition Norms and Procedure) Regulations 2014 before 31.10.2015.
