WHEREAS, Sri Srinivasa Educational Welfare Society, East Godavari District, Andhra Pradesh was granted recognition to B.Ed course of one year duration to Sri Srinivasa College of Education, Padmanabha Colony, Near RTC Complex, Peddapuram, East Godavari District – 533437, Andhra Pradesh on 25.09.2007 from the academic session 2007-2008.

AND WHEREAS, a revised order was issued to the institution on 16.07.2015 with a condition that the institution has not maintained Fixed Deposit Receipts towards Endowment and Reserve Funds.

AND WHEREAS, the society has applied for new D.El.Ed programme SRCAPP2974 for 2016-17 and submitted application of existing B.Ed APS08554 to the new premises.

AND WHEREAS, the SRC in its 296th meeting held on 15th & 16th December, 2015 considered the request and decided to cause composite inspection for B.Ed and D.El.Ed.

AND WHEREAS, the inspection of the institution was fixed between 10th – 30th Jan 2016 and same was intimated to the institution on 16.01.2016. The inspection of the institution was conducted on 29.01.2016 and VT report along with documents received by this on 04.02.2016.

AND WHEREAS, the SRC in its 302nd meeting held on 09th – 11th February, 2016 considered the VT report and all other relevant documents and it has decided that Shifting is permitted for B.Ed (APS08554) course.


NOW THEREFORE, permission is hereby accorded to Sri Srinivasa College of Education, Padmanabha Colony, Near RTC Complex, Peddapuram, East Godavari District – 533437, Andhra Pradesh to shift its premises to new location/building at Sri Srinivasa College of Education, Plot/Khasara No. 876/2A, Peddapuram Village & Post, Peddapuram Taluk & City, East Godavari District – 533437, Andhra Pradesh.

Further, in view of the fact that NCTE Regulations (Recognition, Norms and Standards) 2014 are notified, the institution is required to conform to the new requirements as prescribed in NCTE Regulations (Regulation, Norms and Standards), 2014 and submit compliance before 31.10.2015.

If the institution contravenes any of the conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.

Also order that a copy of this order be published in the Official Gazette.
