- Further, the recognition is subject to fulfillment of all such other requirements as may be 2 prescribed by other regulatory bodies like UGC, affiliating University/ Body, the State Government etc, as applicable.
- The institution shall submit to the Regional Committee a Self-Appraisal Report at the end 3 of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.

- 4 The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:
  - a Sanctioned programmes along with annual intake in the institution;
  - b Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph;
  - c Name of faculty members who left or joined during the last , quarter;
  - d Names of students admitted during the current session along with qualification, percentage of marks in the qualifying examination and in the entrance test, if any, date of admission etc.;
  - e Fee charged from students;
  - f Available infrastructural facilities;
  - g Facilities added during the last quarter;
  - h Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i The institution shall be free to post additional relevant information, if it so desires
- j Any wrong or incomplete information on website shall render the institution liable for withdrawal of recognition
- 5. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.
