WHEREAS, in terms of Section 14(1) of the NCTE Act, 1993 Amadalavalasa Lakshmi Ganapathi Educational Society, Plot No.4-1-146/3, Palakonda Road, Amadalavalasa Village, Post, Taluk & City, Srikakulam District - 532185, Andhra Pradesh has applied for grant of recognition to T.S.R Teacher Training Institute, Khasara No.20/2 & 20/2A, Plot No.4-1-146/3, 18 Ward, Amadalavalasa Village, Post, Taluk & City, Srikakulam District - 532185, Andhra Pradesh for D.Ed course online on 01.10.2011 for two years duration under Section 14 (1) of the NCTE Act, 1993 and received in the Southern Regional Committee NCTE on 10.10.2011.

AND WHEREAS, on scrutiny of the application submitted by the institution, the documents attached therewith the affidavit and the input received from the visiting team in the form of report and videography, the Southern Regional Committee is satisfied that the institution fulfills the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the said teacher education programme such as instructional facilities, infrastructural facilities, library, accommodation, financial resources, laboratories etc., for running the programme and has appointed duly qualified teaching staff as per NCTE norms.

- 3. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.

  - a) Sanctioned programmes along with annual intake in the institution:
  - b) Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph;
  - c) Name of faculty members who left or joined during the last, quarter;
  - d) Names of students admitted during the current session along with qualification, percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
  - e) Fee charged from students;
  - f) Available infrastructural facilities;
  - g) Facilities added during the last quarter;
  - h) Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
  - i) The institution shall be free to post additional relevant information, if it so desires
  - Any wrong or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 5. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.
