WHEREAS, L S Educational Society, Warangal District, Andhra Pradesh had submitted an application for grant of recognition to Talla Padmavathi College of Education, Warangal Revenue Division C/o Learners Land Junior College, Islamia Grounds, Warangal District – 506007, Andhra Pradesh for B.Ed Course and recognition was granted to the Institution vide SRC order dated 04.04.2003 at Warangal Revenue Division, C/o Learners Land Junior College. Islamia Grounds, Warangal District – 506 007, Andhra Pradesh (as per recognition order) with a condition to shift the Institution to permanent premises.

AND WHEREAS, the Institution in its application stated that the Institution possess own land for construction of permanent building.

AND WHEREAS, while going through the records submitted by the Institution, it is found that, the Institution had not shifted to permanent premises as per norms and standards and conditions mentioned in recognition order dated 04.04.2003 / Not communicated the shifting of premises to the SRC and not paid the prescribed fees for shifting of premises.

AND WHEREAS, the matter was considered by SRC in its 178th meeting held on 13th - 14th July 2009 and decided to issue Show Cause Notice.

AND WHEREAS. a show cause notice was issued to the Institution on 02.09.2009 and the institution has submitted its reply on 11.01.2010, 09.02.2010 and 02.12.2010 along with shifting fee of Rs. 40,000/- and documents after the stipulated period of 21 days.

AND WHEREAS, the Institution has submitted a letter on 05.02.2014. The Institution had shifted without prior inspection of new premises and without obtaining permission from NCTE.

AND WHEREAS, the SRC in its 267<sup>th</sup> meeting held during 12<sup>th</sup> & 13<sup>th</sup> May, 2014 considered the matter, decided and advised Southern Regional Office to obtain all the relevant documents for the new premises along with approved staff list in the prescribed format from the institution, for causing inspection.

AND WHEREAS, a letter was addressed to the institution on 26.05.2014. Affidavit sent as per regulations 2014 on 19.12.2014.

**AND WHEREAS**, in response to this office letter dated 19.12.2014, the institution has submitted a reply on 23.01.2015, along with an affidavit on Rs. 100/- stamp paper expressing their willingness for the application to be processed as per Regulation, 2014. The institution is not submitted the documents so for.

AND WHEREAS, the Southern Regional Committee in its 278<sup>th</sup> meeting held during 25<sup>th</sup> January,2015 considered the matter, affidavit submitted by the institution vide letter dated 23.01.2015, decided and advised Southern Regional Office to process and put up with reference to existing documents.

**AND WHEREAS**, on 03.03.2015 a letter is received from, the Principal Talla Padmavathi Institute of Elementary Teacher Education. Urus, Karemabad, Warangal.

AND WHEREAS, the Southern Regional Committee in its 284th meeting held during 9th & 10th April. 2015 considered the matter, all the relevant documents of the institution, and decided to serve Show Cause Notice.

The institution has submitted its written representation on 29.05.2015.

**AND WHEREAS**, the SRC in its 290<sup>th</sup> Meeting held on 10<sup>th</sup>-11<sup>th</sup> July, 2015 considered the matter, written reply from the institution vide their letter dated 29.05.2015 to the show cause notice issued, decided and advised Southern Regional Office as under:

- 1. Collect the Inspection Fee in full and cause inspection.
- 2. Ask the VT to collect the latest approved B.C.C.

AND WHEREAS, the inspection of the institution was fixed between 10<sup>th</sup>-30<sup>th</sup> January, 2016. The same was intimated to the institution on 16.01.2016. The inspection of the institution was conducted on 29.01.2016. The VT report received in this office of SRC-NCTE on 31.01.2016.

**AND WHEREAS**, the SRC in its 308<sup>th</sup> meeting held on 28<sup>th</sup> – 30<sup>th</sup> March 2016, considered the VT report and it has decided to "*Permit shifting*".

NOW THEREFORE, permission is hereby accorded to Talla Padmavathi College of Education(APS00380) & Talla Padmavathi Institute of Elementary Teacher Education(APS02696), Warangal Revenue Division, C/o. Learners Land Junior College, Islamia Grounds, Warangal District – 506007, Telangana to shift its premises to new location/building at Talla Padmavathi College of Education(APS00380) & Talla Padmavathi Institute of Elementary Teacher Education(APS02696), H.No. 7-45/5, Urus, Kareemabad, Warangal - 506002, Telangana.

Further, in view of the fact that NCTE Regulations (Recognition, Norms and Standards) 2014 are notified, the institution is required to conform to the new requirements as prescribed in NCTE Regulations (Regulation, Norms and Standards), 2014 and submit compliance before 31.10.2015.

If the institution contravenes any of the conditions or the provisions of the NCTE Act. Rules. Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.
