WHEREAS, St. Mary's Educational Society, Nalgonda, Andhra Pradesh had submitted an application to the Southern Regional Committee of NCTE for grant of recognition to Universal College of Education, 3-110/3, Nayanagar, Kodad-508206, Nalgonda District, Andhra Pradesh for secondary (B.Ed) course of one year duration from the academic session 2004-05 with an annual intake of 100 students.

AND WHEREAS, the institution was granted recognition on 08.03.2005 with a condition that the institution shall shift to its own premises/building within three years from the date of recognition (in case the course is started in rented premises).

AND WHEREAS, the institution has submitted shifting proposal along with DD of Rs.40,000/- bearing No.120099 dated 03.10.2007 (taken into account) on 03.10.2007 along with relevant documents.

AND WHEREAS, the SRC in its 178th meeting held on 13th-14th July, 2009 considered the list of institutions were accorded recognition in the rented premises and they had not yet shifted to the permanent premises/building and it has decided to issue Show Cause notice under section 17 of NCTE Act and obtain shifting fees and other documents for causing inspection for shifting.

AND WHEREAS, the institution has submitted its written representation on 29.01.2015 along with original willingness affidavit as per regulations 2014. Accordingly, revised recognition order was issued to the institution on 11.05.2015 with a condition that the institution has not shifted to its own premises.

AND WHEREAS, the institution has submitted its written representation on 24.09.2015 along with relevant documents. The SRC in its 292nd meeting held on 29th to 30th Sept 2015, the committee considered the matter and decided as follows:

- The legal position is that so long as NCTE recognition exists, Universities shall give affiliation to the institutions. It is our responsibility to get conditions like 'shifting' implemented. We are taking appropriate action to enforce the conditional ties until action in such cases is completed, Universities may be requested to continue to affiliate the institutions.
- 2. In all conditional recognition cases, we should issue Show Cause Notice for derecognition for non-observance of conditionality. The concerned affiliating Universities may be informed that we are taking action to enforce the conditionality's.

AND WHEREAS, a letter was sent to the Registrar, Mahatma Gandhi University on 06.10.2015.

AND WHEREAS, the SRC in its 300th meeting held on 29th – 31st January, 2016 considered the VT report of complete institution and it has decided to permit shifting.

NOW THEREFORE, permission is hereby accorded to Universal College of Education, 3-110/3, Nayanagar, Kodad-508206, Nalgonda District, Andhra Pradesh to shift its premises to new location/building at Universal College of Education, Sy.No. 469, Charlapally, Hyderabad Road, Nalgonda – 508001, Telangana.

Further, in view of the fact that NCTE Regulations (Recognition, Norms and Standards) 2014 are notified, the institution is required to conform to the new requirements as prescribed in NCTE Regulations (Regulation, Norms and Standards), 2014 and submit compliance before 31.10.2015
