WHEREAS, Ushodaya College of Education, Wanaparthy Revenue Division, 46-57, K.D.R. Nagar, Wanaparthy, Mahabubnagar District-509103, Andhra Pradesh for B.Ed course of one year duration from the academic session 2003-2004 with an annual intake of 100 students. The institution was granted recognition on 23.12.2003 with a condition that the institution shall shift to its own premises within three years from the date of recognition (in case the course is started in rented premises).

AND WHEREAS, the SRC in its 178th meeting held on 13-14 July 2009 considered institutions who have not shifted to its permanent premises as per norms and standards and decided to issue show cause notice under section 17 of NCTE Act and obtain the documents.

AND WHEREAS, a letter/show cause notice was sent to the institution on 28.08.2009 regarding submission of documents along with inspection fee of Rs.40,000/-. No reply received from the institution so far.

AND WHEREAS, the institution has submitted willingness affidavit as per regulation 2014 on 04.02.2015.

AND WHEREAS, revised recognition order was issued to the institution on 12.05.2015 with a condition that the institution has not shifted to its own premises stipulated in its formal recognition order dated 23.12.2003.

AND WHEREAS, the institution has submitted its written representation on 24.07.2014 along with documents.

AND WHEREAS, the institution has submitted its written representation on 19.02.2016 along with documents. SRC in its 304th meeting held on 19th & 20th February, 2016 considered the matter and decided as under:

- 1. That this case has some urgent 'admission' issues.
- Cause composite inspection for B.Ed (2Units) and D.El.Ed (1Unit).

AND WHEREAS, inspection intimation was sent to the institution and VT members. The Inspection of the institution was conducted on 23.02.2016 and VT report along with documents received on 24.02.2016.

AND WHEREAS, SRC in its 305th meeting held on 25th & 26th February, 2016 considered the VT report and other relevant documents of the institution and decided to 'shifting permitted for both B.Ed & D.Ed and Affiliating body to be informed for certificate of affiliating and admission.'

NOW THEREFORE, permission is hereby accorded to Ushodaya College of Education, Wanaparthy Revenue Division, 46-57, K.D.R. Nagar, Wanaparthy, Mahabubnagar District-509103, Andhra Pradesh (APS00370 - B.Ed) to shift its premises to new location/building at Ushodaya College of Education, D.No. 9-60, Khasara No. 198 & 199, Srinivasapoor Village, Wanaparthy Mandal & Post, Mahaboobnagar District - 509103, Telangana
