#### ORDER

WHEREAS, Vikas Christian Educational Society, Regd No.5501/97, FF-I, Bhavani Mansions, Street.No.4, Tarnaka, Secunderabad-17, Andhra Pradesh has submitted an application to the Southern Regional Committee of NCTE for grant of recognition to V C College of Education, H.No.3-8-32, Kanchara Bazar, Suryapet, Nalgonda District, Andhra Pradesh for B.Ed course of one year duration from the academic session 2002-03 with an annual intake of 100 students granted recognition order on 12.05.2003 with a condition to shift the institution to permanent premises.

AND WHEREAS, the institution has submitted its written representation on 21.04.2008 along with DD of Rs.40, 000/- for proposal of shifting the institution to the permanent building location.

AND WHEREAS, a letter was issued to the institution for submit the documents for examining the proposal for shifting submitted by the institution on 25.05.2009.

AND WHEREAS, a letter received from Registrar, Osmania University, it has furnished information pertaining to the affiliated Teacher Education Center Institutions offering the course in own/permanent/temporary leased buildings vide letter dated 4th May 2009.

AND WHEREAS, the SRC in its 176th meeting held on 27th-28th July 2009, and it has decided to issue show cause notice under section 17 of NCTE Act to all the institutions which have been functioning against Regulations of NCTE 2007. Further, the committee decided to send an appreciation letter to the Registrar, Osmania University for giving information about the functioning of the Teacher Education institutions.

AND WHEREAS, accordingly, show cause notice was issued to the institution on 02.07.2009. The institution has submitted its written representation on 24.08.2011 regarding missing of FDRs of Rs.5 lakh & Rs.3 lakh.

AND WHEREAS, a letter was issued to the institution on 25.08.2011 for the response of 24.08.2011.

AND WHEREAS, the institution has submitted its written representation on 05.02.2014 stating

"....issue necessary permission to shift our college from the leased building to our own building through our letter first cited. A draft bearing No.778757 dated 15.04.2008 for Rs.40,000/- required towards fee for shifting has been sent to you. In this connection I wish to state that the Registrar, Osmania University, Hyderabad has approved the suitability of the own building after inspecting the premises and the infrastructural facilities. The fact of acceptance and approval has been communicated to us through the letter second cited.In view of the facts stated I request you to issue necessary permission to shift the building to the new premises of our own construction. A copy of the letter first cited and the letter second cited are submitted herewith for favour of your the letter meady reference.

AND WHEREAS, the Committee in its 262<sup>nd</sup> Meeting held on 17<sup>th</sup> - 19<sup>th</sup> February, 2014 considered the matter, request of the institution for shifting inspection, and decided that

 SRO to obtain all relevant documents (including Approved Staff list) relating to the new premises, examine and, to be put up.

The institution to be informed to pay Rs. 10,000/-more towards the Inspection fee.

AND WHEREAS, as per the decision of SRC, a letter was issued to the Institution on 26.02.2014 with direction to submit the relevant documents including approved staff list and Balance fees of Rs. 10000/-.

The Southern Regional Committee in its  $268^{th}$  Meeting held on  $4^{th} - 5^{th}$  June, 2014, considered the matter, reply of the institution vide their letter dated 28.03.2014, decided to await notification of the new Regulations as per NCTE (H.Q) instructions.

AND WHEREAS, the Sothern Regional Committee in its 278th Meeting held on 25th January, 2015 considered the matter, consider the Cause Composite inspection is as under:

AND WHEREAS, the inspection of the institution was conducted on 05.02.2015 and the VT Report was received by this office on 09.02.2015

AND WHEREAS, SRC, in its 280<sup>th</sup> meeting held on 12<sup>th</sup> to 14<sup>th</sup> February, 2015, considered the matter and decided to Issue *Show Cause Notice for latest approved staff list*.

AND WHEREAS, in the meantime, on before insuring Show Cause Notice, as per website information decided to a reply received from the Correspondent V.C College of Education, H.No.3-8-32, Kanchara Bazar, Suryapet, Nalgonda District, Andhra Pradesh on 19.02.2015.

AND WHEREAS, On 24.02.2015, a letter dated 25.02.2015, received by this office from the V.C College of Education, Rayanigudem Village, Suryapet Mandal, Nalgonda District-508376, regarding:-

"I submit that the teaching staff for the academic year 2014-15 has been approved and the orders already communicated to us through the letter cited. As seen from 280<sup>th</sup> meeting of SRC 12-14 February 2015 our college is directed to submit the list of teaching staff approval.

In this connection I wish to inform you the fact and I submit here with a copy of the approved letter for favour of your ready reference "

AND WHEREAS, the SRC in its 282<sup>nd</sup> meeting held on 26<sup>th</sup> February, 2015 considered the matter, reply of the institution vide letter dated 19.02.2015, all the relevant documentary evidences of the institution and decided to serve Show cause Notice under NCTE act, for the following deficiencies.

- "1. The staff list does not give details of subject specialization and designations
- Two positions (Physical Education and Fine Arts) are vacant.
   Principal does not have Ph.D."

**AND WHEREAS,** as per the decision of SRC, a Show Cause Notice was issued to institution on 09.03.2015. The institution has submitted written representation on 08.04.2015.

AND WHEREAS, the SRC in its 285<sup>th</sup> Meeting held on 17<sup>th</sup> April, 2015 considered the show cause notice reply and the committee has decided to shifting is permitted.

Sanctioned programmes along with annual intake in the institution;

b) Name of faculty and staff in full as mentioned in school certificate along with their qualifications. scale of pay and photograph.

c) Name of faculty members who left or joined during the last, quarter.

d) Names of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;

e) Fee charged from students;

f) Available infrastructural facilities;

g) Facilities added during the last quarter;

h) Number of books in the library, journals subscribed to and additions, if any, in the last quarter,

i) The affidavit with enclosure submitted along with application.

The institution shall be free to post additional relevant information. if it so desires.

k) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

If the institution Contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and Orders made of issued there under , the institution will render itself vulnerable to adverse action including withdrawal of recognition by the regional committee under the provisions of Section 17(1) of the NCTE Act.

#### ORDER

WHEREAS, in exercise of the powers conferred by sub-section(2) of Section 32 of the National Council for Teacher Education Act, 1993(73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 1.12.2014.

- AND WHEREAS, the institution, V.C. College of Education, Rayanigudem-508376,
   Suryapet Post, Nalgonda District, Andhra Pradesh has by affidavit consented to come under New Regulations and sought for two basic units in B.Ed which require additional facilities
- AND WHEREAS, it has been decided to permit the institution to have two basic units of 50 students each subject to the institution fulfilling following conditions namely,
  - The institution shall create additional facilities that include (a) additional built-up area, (b) additional infrastructure, (c) additional funds, (d) additional staff as per Regulations, 2014 and inform Regional Committees with required documents by October 31, 2015.
  - II. The applicant-institution for additional unit will be required to subm/it the required documents B, such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC), Building Plan (BP) and the Approved Staff List in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building Completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting team at the time of inspection.
  - III. The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these conditions by 20 Feb, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017
- 4. NOW THEREFORE, in the light of the above and in terms of Section 14(3) of NCTE Act and in accordance with the Regulations, 2014, the Southern Regional Committee, NCTE hereby grants recognition V.C. College of Education, Rayanigudem-508376, Suryapet Post, Nalgonda District, Andhra Pradesh for conducting B.Ed programme of two years duration with an annual intake of 100 students each for two basic units from the academic session 2015-16 subject to , fulfilment of the conditions mentioned herein before 31.10.2015
- Further, the recognition is subject to fulfilment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc, as applicable.
- The institution shall submit to the Regional Committee a Self- Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a chartered Accountant
