The SRC in its 203rd meeting held on 31st March & 1st April 2011 considered the written representation of the institution and decided to issue Final Showcause notice. Accordingly, Final Showcause notice was issued to the on 05.05.2011. The institution has submitted its written representation on 16.05.2011.

The SRC in its 206th meeting held on 9-10 June 2011 considered the VT report of the institution, reply of the institution to the show cause notice and other related documents along with the original file of the institution, and decided that shifting of D.Ed (APS01615) course to new/permanent premises is permitted.

ORDER


