WHEREAS, in terms of Section 14(1) of the NCTE Act, Sri Vasavi Kanyaka Parameshwari Educational Society, Plot No.215,216, 217/1, 217/2, Ravipadu Road, Kandulapuram Village, Cumbum Post Office, and Taluk, Cumbum Town/ City, Prakasam District-523333, Andhra Pradesh had submitted an on-line application to the Southern Regional Committee of NCTE on 30.05.2015 and submitted printouts on 04.06.2015 for grant of recognition for B.Ed Programme of two units of 100 Students at Vasavi B.Ed College, Plot/Khasara No.215, 216, 217/1, 217/2, Land Title: S.V.K.P. AND WHEREAS, on scrutiny of the application submitted by the institution, the documents attached therewith, the affidavit submitted and the report received from VT and Videography, and the certificates received from the university, the Committee is satisfied that the applicant fulfils the requirements under the provisions of NCTE ACT, Rules and relevant Regulations including the Norms and Standards for the said teacher education programme such as instructional facilities, infrastructural facilities, financial resources, etc., for running the programme.

NOW THEREFORE, in exercise of the powers vested under Section14(3) (a) of the of the NCTE ACT, 1993, the Regional Committee, NCTE hereby grants recognition to Vasavi B.Ed College, Plot/Khasara No.215, 216, 217/1, 217/2, Land Title: S.V.K.P. Educational Society, Kandulapuram Village, Cumbum Post Office and Taluk, Cumbum Town/City, Prakasam District-523333, Andhra Pradesh for conducting B.Ed programme of two years duration with an annual intake of 100 students from the academic sessions 2016-2017 under Clause 7(16) of NCTE (Recognition Norms & Procedure) Regulations, 2014 subject to fulfillment of the following conditions:-

- The Endowment fund of 5 lakhs and Reserve fund of 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Loan raising against or mortgaging of FDR's shall not be done.

- 3 The institution shall submit to the Regional Committee a Self- Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a chartered Accountant.
