ORDER

In terms of Section 15(1) of the NCTE Act, 1993 **Vikas Telugu Pandit Training College, 4-24, Near Kalika Temple, Himyatsagar Road, Bandlaguda Jagir, Ranga Reddy Dt. - 500 030, Andhra Pradesh** had submitted an application to the Southern Regional Committee of NCTE for grant of permission for an **additional intake of 50 thus making the total intake of 100 for Telugu Pandit Training Course of One year** duration from the academic session **2004-2005**.

2. On scrutiny of the application submitted by the institution, the documents attached therewith and the input received from the visiting tea, the Committee has noted the following:

- i) The institution has acquired the land for setting up the teacher education institution.
- ii) The institution has made arrangements for conducting the course in rented premises.
- iii) The institution has created an Endowment fund and Reserve fund of Rs.1,50,000/-
- iv) The institution has selected the Principal/Head and **Four** teachers and two guest lecturers for the said course and the list of faculty members has also been approved by the affiliating University(in the case of degree level teacher education programmes) /SCERT/ Directorate of Elementary Education or the concerned Directorate (in the case of Diploma level teacher education programmes).

Now, therefore, in exercise of the powers vested under Section 15(3)(a) of the NCTE Act, 1993, the Regional Committee hereby grants permission to **Vikas Telugu Pandit Training College, 4-24, Near Kalika Temple, Himyatsagar Road, Bandlaguda Jagir, Ranga Reddy Dt. - 500 030, Andhra Pradesh** for an **additional intake of 50** students in **Telugu Pandit Training** course of one year duration from the academic session **2004-2005** thus making a total annual intake of **100** students subject to fulfillment of the following:

- a) That the institution will ensure that **1+4** faculty members duly approved by the affiliating University/SCERT/Directorate of Elementary Education/concerned Directorate are in position for an intake of **100** students before commencement of the course and a report to this effect shall be sent to the Regional Committee within one month of the commencement of the course.

- b) The institution shall, within one month of the receipt of order of permission, convert the endowment fund account into a joint account to be operated along with an official of the Regional Committee.
 - c) The institution shall shift to its own premises within three years from the date of permission. (In case the course is started in rented premises)
 - d) The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations.
3. Further, the permission is subject to fulfillment of all such other requirements as may be prescribed by other regulator bodies like UGC and the State Government etc.
 4. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating University/concerned State Council/Directorate of Education to the appointment of faculty members, and the statement of annual accounts duly audited by a Chartered Accountant.
 5. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued thereunder, the Regional Committee may withdraw the permission under the provisions of Section 17(1) of the NCTE Act.
