PREAMBLE :

Vinayaga Teacher Training Institute, P.B No-1851, Vinayaga nagar, Karuppur, Keelapaluvur (PO), Ariyalur (Tq) Perambalur District -621707 Tamilnadu had submitted an application to the Southern Regional Committee of NCTE for grant of recognition for Elementary(D.T.Ed) course.

Hon'ble High Court of Madras in W.P. No.5555 of 2005 dated 21.2.2005 has directed NCTE to cause inspection within a period of Four weeks. Accordingly, the first inspection was carried out on 20.09.2005. The inspection report was placed before 100th SRC meeting held on 23-24 September, 2005. SRC decided to cause re-visit to the institution. A second visit was organized on 22.11.2005 and the V.T. report was placed before SRC in its 106th SRC meeting held on 15-16th December 2005 and the SRC deferred the decision. The matter was again considered in the 107th meeting held on 27th December 2006. SRC decided to call for the original building plan for verification. A letter to the institution communicating the decision of SRC was issued on 4th January, 2006. The written representation submitted by the institution dated 6th January, 2006 was placed before SRC in its 108th meeting held on 17-18 January, 2006. SRC considered the written representation and noted certain deficiencies and decided to issue notice to the institution under Section 14(3)(b) of NCTE Act. Accordingly a notice mentioning the deficiencies pointed out by SRC was issued on 31st January, 2006. The written representation submitted by the institution dated 1st February, 2006 was placed before SRC in its 109th meeting held on 2nd February, 2006. SRC considered the written representation and decided to accord recognition to the institution for D.T.Ed. course with an annual intake of 50 students from the academic session 2005-06.

Some of the institutions who have been granted recognition for the subsequent year have preferred appeal before NCTE, New Delhi to reconsider their cases of grant of recognition for the session 2005-06 itself instead of 2006-07. The NCTE, New Delhi vide order No.F.No.89/156/2005-Appeal dated 28.9.2005 has remanded back the case to SRC with a direction to reconsider these cases immediately for grant of recognition for the session 2005-06 on par with other similar cases who have been granted recognition for 2005-2006.

Hence the order.


In terms of Section 14(1) of the NCTE Act, 1993 **Vinayaga Teacher Training Institute, P.B No-1851, Vinayaga nagar, Karuppur, Keelapaluvur (PO), Ariyalur (Tq) Perambalur District -621707 Tamilnadu** had submitted an application to the Southern Regional Committee of NCTE for grant of recognition for **Elementary(D.T.Ed)** course of two year duration from the academic session 2005-06 with an annual intake of **50** students.

- 1 On scrutiny of the application submitted by the institution, the documents attached therewith and the input received from the visiting team, the Committee has noted the following:
 - a. The institution has acquired the land for setting up the teacher education institution.
 - b. The institution has made arrangements for conducting the course in the rented premises.
 - c. The institution has created an Endowment Fund of Rs. 5 Lakhs and a Reserve Fund of Rs. 3 Lakhs.
 - d. There is an Endorsement from the State Government of Tamilnadu dated 13.4.2005
 - e. The institution has selected the **Principal and Five** lecturers for the said course.
2. Now, therefore, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Southern Regional Committee hereby grants recognition to **Vinayaga Teacher Training Institute, P.B No-1851, Vinayaga nagar, Karuppur, Keelapaluvur (PO), Ariyalur (Tq) Perambalur District -621707 Tamilnadu** for Elementary(D.T.Ed) course of **two year** duration from the session 2005-06 with an annual intake of 50 students subject to fulfillment of the following.
 - a. The institution will ensure that **Six** exclusive faculty members (**Principal and Five teachers**) duly approved by the DTERT are in position for an intake of 50 students and a report to this effect shall be sent to the Southern Regional Committee immediately and in any case before commencement of admissions for the course.
 - b. The institution shall shift to its own premises within three years from the date of recognition (in case the course is started in temporary premises).



- c. The institution shall, within one month of the receipt of recognition order, convert the endowment fund account into a joint account to be operated along with an official of the regional Committee.
- d. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations.
3. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like the State Government etc.
4. The institution shall submit to the Regional Committee a Performance Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating authority to the appointment of faculty members, and the statement of annual accounts duly audited by a Chartered Accountant.
5. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued thereunder, the Southern Regional Committee may withdraw the recognition under the Provisions of Section 17(1) of the NCTE Act, 1993.
