AND WHEREAS, on scrutiny of the application submitted by the institution, the documents attached therewith, the affidavit submitted and the report received from VT and Videography, and the certificates received from the university, the Committee is satisfied that the applicant fulfils the requirements under the provisions of NCTE ACT, Rules and relevant Regulations including the Norms and Standards for the said teacher education programme such as instructional facilities, infrastructural facilities, financial resources, etc., for running the programme.

NOW THEREFORE, in exercise of the powers vested under Section14(3) (a) of the of the NCTE ACT, 1993, the Regional Committee, NCTE hereby grants recognition to Vishwadarshana Educational Society, Yellapur, Plot No. 31A, Idagundi Village & Post, Yellapur Taluk & City, Uttara Kannada-581337, Karnataka for conducting B.Ed programme of two years duration with two units of 50 students each from the academic sessions 2017-2018 under Clause 7(16) of NCTE (Recognition Norms & Procedure) Regulations, 2014 subject to fulfillment of the following conditions:-

- 1. The Endowment fund of 5 lakhs and Reserve fund of 7 lakhs kept in joint account with Regional Director of NCTE should be maintained Perpetually. Loan raising against or mortgaging of FDR's shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- III. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in Position.
- 2 Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University / Body. the State Government etc, as applicable
- The institution shall submit to the Regional Committee a Self- Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a chartered Accountant.
- 4. The institutions shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter –alia, the details of the institution, its location, name of the programme applied for with intake; availability of physical infrastructure, such as Ind, building, office, classrooms, and other facilities or amenities; instructional facilities, such as laboratory and library and the particulars of their proposed teaching faculty and non-teaching staff with photographs, for information of all concerned.
