AND WHEREAS, on scrutiny of the application submitted by the institution, the documents attached therewith, the affidavit submitted and the report received from VT and videography, and the certificates received from the university, the Committee is satisfied that the applicant fulfils the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the said teacher education programme such as instructional facilities, infrastructural facilities, financial resources, etc., for running the programme.


- The Endowment fund of Rs.5 lakhs and Reserve fund of Rs.7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Loan raising against or mortgaging of FDR's shall not be done.
- The institution shall comply with the various other norms and standards prescribed in the 11. NCTE regulations, as amended from time to time.
- The institution shall make admission only after it obtains affiliation from the examining 111. body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations 2014.
- The institution shall ensure that the required number of academic staff duly approved by IV. affiliating body for conducting the course should always remain in position.
- 2. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University / Body, the State Government etc, as applicable.
- The institution shall submit to the Regional Committee a Self- Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- The institutions shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter -alia, the details of the institution, its location, name of the programme applied for with intake; availability of physical infrastructure, such as land, building, office, classrooms, and other facilities or amenities; instructional facilities, such as laboratory and library and the particulars of their proposed teaching faculty and non-teaching staff with photographs, for information of all concerned. Sanctioned programmes along with annual intake in the institution:

- a. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- b. Name of faculty members who left or joined during the last, quarter:
- c. Names of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- d. Fee charged from students;
- e. Available infrastructural facilities;
- f. Facilities added during the last quarter;
