ORDER

Preamble:-

WHEREAS, Aaronic Radiating Society, Plot No. 43/32B, Nrpeta Road, Kurnool Village, Nrpeta Post, Kurnool Taluk & District-518 004, Andhra Pradesh had applied for grant of recognition to Varaprasad Rao D.Ed College, Khasara/Plot No.375/B2B, Panchalingala Village, Kurnool post, Taluk & District-518 004, Andhra Pradesh for starting D.Ed course of two years duration and section 14(l) of NCTE Act, 1993 to the SRC, NCTE online on 30.09.2011 and physical application has been received in the office of SRC on 03.10.2011.

AND WHEREAS, recognition order was issued vide order F.No.SRCAPP1472/D.Ed/AP/2013-14/51998 dated 01.06.2013 for D.Ed course with an intake of 50 students from the academic session 2014-15 as per Supreme Court Order dated 13.12.2012 filed by Maa Vaishno Devi Mahila Maha Vidyalaya.
