WHEREAS, in terms of Section 14(1) of the NCTE Act, 1993 Baba Educational and Rural Development Society, Plot No. 3-99, Sivalingampalli Street, Kadapa Village, Post & Taluk, Kadapa District-516001, Andhra Pradesh has applied for grant of recognition to Vikas Teacher Training Institute, Khasara No. 1560/1A & 1559, C.K. Dinne Village, Post & Taluk, Kadapa District-516001, Andhra Pradesh for D.Ed course online on 28.09.2011 for two years duration under Section 14 (1) of the NCTE Act, 1993 and received in the Southern Regional Committee NCTE on 03.10.2011.

- 3. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.

- 4. The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:
  - a) Sanctioned programmes along with annual intake in the institution;
  - b) Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph;
  - c) Name of faculty members who left or joined during the last, quarter;
  - d) Names of students admitted during the current session along with qualification, percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
  - e) Fee charged from students;
  - f) Available infrastructural facilities;
  - g) Facilities added during the last quarter;
  - h) Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
  - i) The institution shall be free to post additional relevant information, if it so desires
  - j) Any wrong or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 5. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.
