
- 1. The Endowment fund of Rs.5 lakhs and Reserve fund of Rs.7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Loan raising against or mortgaging of FDR's shall not be done.
- The institution shall comply with the various other norms and standards prescribed in the 11. NCTE regulations, as amended from time to time.
- The institution shall make admission only after it obtains affiliation from the examining body in Ш. terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations 2014.
- The institution shall ensure that the required number of academic staff duly approved by IV. affiliating body for conducting the course should always remain in position
- 2. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University / Body, the State Government etc. as applicable.
- 3. The institution shall submit to the Regional Committee a Self- Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 4. The institutions shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter -alia, the details of the institution, its location, name of the programme applied for with intake; availability of physical infrastructure, such as land, building, office, classrooms, and other facilities or amenities; instructional facilities, such as laboratory and library and the particulars of their proposed teaching faculty and non-teaching staff with photographs, for information of all concerned.
