The bidder is required to submit the quotation alongwith EMD (Earnest Money Deposit) of Rs. 10,000/- in the shape of Bank Draft in favour of "Member Secretary, National Council for Teacher Education."

The tender should reach the undersigned by registered post/speed post or by hand on or before **16th April, 2015 upto 3.00 PM** at the latest & tenders received shall be opened by the Members of the Committee constituted for the same.

The bidders should submit the bid form duly completed in all respects along with attested copies of license/ Identity Card/ Election Card as a proof of identity/ address. The bid should be put in a box in the office of Member Secretary, NCTE. The undersigned will not held responsible regarding late submission/receive of tender in any manner.

The bid will be opened on dated **16th April, 2015 at 4:30 P.M.** before the Members of the Committee constituted for the same. The desirous bidders may be present at that time. The highest tenders, whose tender is accepted, shall deposit immediately 25% of the offered amount then & there as initial deposit. He shall deposit the balance amount within 7 days of the deposit of initial amount. In case, he fails to make deposit of the total amount as per tender within the stipulated time, the deposit including the earnest money shall be forfeited. The EMD of successful bidder can be adjusted at the time of final payment of tender value in time.

The successful bidder will be required to take physical possession of the vehicle within 7 days of the deposit of the bid amount failing which the EMD would be forfeited. The EMD of unsuccessful bidders will be returned within one week after opening of bid.
