Sub: <u>Providing reasonable opportunity for making written representation before withdrawal of recognition under section 17 of NCTE Act, 1993-reg.</u>

Sir/Madam,

In terms of Section 14 (3)(a)/15 (3) (a) of the NCTE Act, 1993, the Eastern Regional Committee grated recognition to No. Education Department, Babasaheb Bhimrao Ambedkar Bihar University, Plot no-742,743, Main Road, Vill - Khabra, Po - B. U. Campus, Tehsil/Taluka-Muzaffarpur, Town/City-Muzaffarpur, Dist-Muzaffarpur, Bihar-842001 for conducting B.Ed. M.Ed (3 Year Integrated) vide recognition Order: ER-237.6.49/ERCAPP2681/ 3 Yr. Intergrated B.Ed. M.Ed/2017/52391 dated: 18/04/2017 with annual intake of 50 students.

- 2. The provision of sub-clause 12 of clause 8 of NCTE Regulations, 2014 as amended from time to time provides that the institution shall make the information or documents available to the Council or its authorized representative as and when required by them and failure to produce or show any of the required documents shall be treated as a breach of the condition of recognition.
- 3. National Council for Teacher Education issued a Public Notice dated 29.09.2021 regarding online submission of the Performance Appraisal Report (PAR), by all TEls, on the NCTE portal (http://ncte.gov.in/Website/PAR.aspx) for the academic session 2020-2021 from 30.09.2021 to 15.03.2022 (mid night). In compliance to the Order dared 25.02.2022 passed by the Hon'ble High Court of Delhi, the timeline to submit the online PAR was extended till 31.03.2022 which was further extended upto 02.04.2022 in the light of Order dated 01.04.2022 passed by the Hon'ble Supreme Court of India.

- 4. Despite extension of timeline to file PAR in the light of Order passed by the Hon'ble Supreme Court of India, your institution has not filed PAR which is clear violation of sub clause 12 of clause 8 of NCTE Regulations, 2014 and also a breach of condition of recognition.
- 5. The matter has been considered by ERC in its 306th meeting held on 12th&13th July,2022 and the committee *inter-alia* decided as under:-

The Show cause notice under section 17 (1) of NCTE Act, 1993 be issued to the all institutions which have not filed PAR on the ground that the institution has breached the condition of recognition as per the provision of clause 8 (12) of NCTE Regulations, 2014 and also clause 7 (14) of NCTE, Regulation, 2014 which is related to uploading information on the website, if the web site of these institutions are not working.

- 6. In view of above facts and decision taken by ERC, you are hereby required to show cause as to why recognition granted to your institution for conducting **B.Ed. M.Ed (3 Year Integrated)** course vide above referred Recognition Order should not be withdraw under Section 17 of NCTE Act, 1993.
- 7. In terms of decision taken by ERC, you are requested to submit your written representation within 30 days from the date of issue of this show cause notice. No further opportunity shall be provided in this regard.
