**RESTORATION ORDER**

**WHEREAS**, in terms of Section 14/15 of the NCTE Act, 1993, **Department of Education, Dibrugarh University, Dibrugarh, Assam- 781316** was granted recognition for B.Ed. Course of one year duration with an intake of 50 vide ERC's Order No. ERC/7-16/2001/283 dated 05.02.2001, followed by revised recognition for B.Ed. course of two years duration with an intake of 50 students (One Basic Unit) from the academic session 2015-2016 vide Order No. ERC/NCTE/AS-S/E-1/96/B.Ed. (Revised Order)/2015/31954 dt. 23.05.2015, as per NCTE Regulations, 2014.

2. **AND WHEREAS**, as per decision taken by ERC in its 282<sup>nd</sup> meeting held on 8<sup>th</sup> & 9<sup>th</sup> July, 2020, the recognition granted to the institution was withdrawn by ERC vide order No. 62834 dated 27.07.2020.

3. **AND WHEREAS**, the institution had filed an appeal before the Council (NCTE) under section 18 of NCTE Act, 1993 against the withdrawal order dated 27.07.2020. The Appellate Authority passed order dated 19.10.2020 and remanded back the case to ERC for re-consideration.

4. **AND WHEREAS**, in compliance of Appeal order dated 19.10.2020, the case was considered by ERC in its 290<sup>th</sup> Meeting (Part-1) held on 3<sup>rd</sup> March, 2021 and as per decision Show Cause Notice dated 16.03.2021 was issued to the institution on the certain deficiencies. The reply of SCN submitted by the institution was considered by ERC in its 302<sup>nd</sup> ERC (Virtual) Meeting held on 28<sup>th</sup> February and 1<sup>st</sup> March, 2022 and as per decision final Show Cause u/s 17(1) was issued to the institution on 08.03.2022. The reply of final SCN submitted by the institution was considered by ERC in its 306<sup>th</sup> (Virtual) meeting held on 12<sup>th</sup> - 13<sup>th</sup> July, 2022 and committee decided that **the recognition for B.Ed. course with an annual intake of 50 seats (One Unit) be restored.**

5. **NOW THEREFORE**, in terms of above decision of ERC, the recognition granted to the institution viz. **Department of Education, Dibrugarh University, Dibrugarh, Assam- 781316** vide order No. F.ERC/NCTE/AS-S/E-1/96/B.Ed. (Revised Order)/2015/31954 dated 23.05.2015 for B.Ed. course with annual intake of 50 seats (one unit) is hereby restored.
