FINAL SHOW CAUSE NOTICE

WHEREAS, in terms of Section 14(1) of the NCTE Act, 1993 Swargiye Ramchandra Prasad Seva Sansthan, Plot No.- 931, Street/Road- Nawada Road, Vill/Town/City- Matuk Bigha, P.O.- Babhaur, Tehsil/Taluka- Chatihar, Town/City- Hisua, Dist.- Nawada, Bihar- 805103 has applied for grant of recognition to RP B.Ed. College, Plot No.- 931, 932, 935, 896, Street No.- Nawada Road, Vill.- MatukBigha, P.O.- Babhaur, Tehsil/Taluka- Chatihar, Town/City-Hisua, Dist.- Nawada, Bihar- 805103 and recognition granted to B.Ed. Course with an intake of 100 from the academic session 2019-20 vide order dated 27.02.2019.

2. AND WHEREAS, A complaint dated 23.07.2021 against the institution made through email by Dr. Md. Enam of Gaya (Bihar) received in ERC-NCTE through Complaint Section, NCTE HQrs. New Delhi. Para-wise reply on the complaint was sought from the institution vide ERC letter no. 64444 dated 08.09.2021 followed by Reminder letter vide no.64766 dated 3.12.2021.

3. AND WHEREAS, the institution submitted reply vide letters dated 06.10.2021 received on 08.11.2021 and another letter dated 21.12.2021 received on 31.12.2021.

4. AND WHEREAS, copy of writ petition in CWJC No. 21159/2021 titled Dr. Md. Enam v/s The State of Bihar &Ors in the Hon'ble High Court of Judicature at Patna received in ERC NCTE, seeking following relief by the complainant

- Directing the concerned authority to make vigilance enquiry for prevalent irregularities/ embezzlement of fund play/ defalcation of money and acting against the direction of the university instructions and against norms and standards of the National Council for Teacher Education by the Managing Committee of R.P. B.Ed. College.
- Commanding the Respondent to make payment of salary of the petitioner for 30 months for the post of Principal, R.P. B.Ed. College, that is, Rs. 65,000/- per month since the date of appointment, that is, 25.01.2019.

5. AND WHEREAS, the ERC in its 303rd (Virtual) meeting held on 24th March, 2022 considered the matter and made following observations:


"The original file of the Institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by ERC and the Committee made following observations:

The institution is still deficient on the following grounds:

- The institution is required to submit details of disbursement of salary along with their accounts details of teaching and non teaching staff.
- The institution is required to submit latest faculty list with photograph approved by the concerned affiliating body alongwith requisite documents/ certificate/testimonials.

Hence Final Show Cause Notice under Section 17(1) of the NCTE Act, 1993 be issued to the institution to submit their reply along with supported documents accompanied with notarized affidavit of Rs. 100/- on Non-judicial stamp paper by the authorized representative of the Management within 30 days from the date of issue of show cause notice.”

6. **NOW THEREFORE**, the institution is required to submit the individual representation/compliance accompanied with an affidavit on Rs.100/- Non-Judicial Stamp paper by the authorized representative of the Management. The representation along with an affidavit must reach this office within the time specified at the end.

7. In case the reply submitted is incomplete or factually incorrect or not received in this office by the date mentioned at the end of this letter, then proceeding under Section 17 of the NCTE Act shall be brought to logical conclusion without any further opportunity provided in the matter whatsoever.

8. Your reply, being complete in all respects must reach this office on or before 30 days i.e. ...10.../05.../2022.


