**FINAL SHOW CAUSE NOTICE**

WHEREAS, in terms of Section 14(1) of the NCTE Act, 1993, Goaltore Educational Training Institute, Vill-Subalbandi, P.O.-Jirapara, Tehsil/Taluka-Goaltore, District-Midnapore, West Bengal-721121 had submitted an application to the Eastern Regional Committee of NCTE through online mode on 28.12.2012 followed by hard copy received on 31.12.2012 for grant of recognition to D.El.Ed. course of one year duration.

2. **AND WHEREAS**, the institution was granted recognition under Clause 7(11) of NCTE (Recognition Norms & Procedure) Regulation, 2009 for conducting D.El.Ed. course of two year duration with an annual intake of 50 (one basic unit) from the academic session 2014-2015 vide order No. 24326 dated 03.03.2014.

3. **AND WHEREAS**, a complaint letter dated 28.08.2015 & 25.01.2017 received from Sh. Ramkrishna Pal, (President), Goaltore Educational Training Institute, Vill.-Subalbandi, P.O.-Jirapara, Tehsil/Taluka-Goaltore, Dist.-Midnapore, West Bengal-721121. Accordingly, a letter dated 21.12.2017 was issued to the institution for point wise reply.

4. **AND WHEREAS**, in response to ERC letter dated 21.12.2017, the institution has submitted reply dated 29.01.2018 received in this office on 31.01.2018, the institution has not submitted any reply/document within the stipulated period, followed by reminder letters dated 20.12.2018 & 09.01.2019 issued to the institution, which was returned undelivered on 01.01.2018 & 31.12.2018, which has placed before the ERC in its 282<sup>nd</sup> Meeting held on 8<sup>th</sup> – 9<sup>th</sup> July, 2020 and decided as under:

The Committee discussed the various complaint cases received against the Goaltore Educational Training Institute, Vill.-Subalbandi, P.O.-Jirapara, Tehsil/Taluka-Goaltore, Dist.-Midnapore, West Bengal-721121 and decided to issue show cause notice under section 17 of the NCTE Act, 1993 to submit reply within 21 days from the date of issue of show cause notice on following grounds.

1. Meeting register of the Trust/Society & bye laws.
2. Constitution of the society and name of the members including Secretary and Presidents.
3. Faculty list (Teaching, non- teaching) approved by affiliating body to be submitted.

Accordingly, Show Cause notice under section 14/15(3)(b) of NCTE Act, 1993 vide no.62896 dated 13.08.2020 issued to the institution. The institution not submitted reply of SCN.

5. **AND WHEREAS**, the ERC in its 303<sup>rd</sup> meeting held on 24<sup>th</sup> March, 2022 the original file of the Institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, direction of appellate authority were carefully considered by ERC and the Committee made following observations:

Hence Final Show Cause Notice under Section 17(1) of the NCTE Act, 1993 be issued to the institution to submit their reply alongwith supported documents accompanied with notarized affidavit of Rs. 100/- on Non-judicial stamp paper by the authorized representative of the Management within 30 days from the date of issue of show cause notice.

6. NOW THEREFORE, the institution are required to submit the individual representation/ compliance accompanied with an affidavit on Rs.100/- Non-Judicial Stamp paper by the authorized representative of the Management. The representation along with an affidavit must reach this office within the time specified at the end.

In case the reply submitted is incomplete of factually incorrect of not received in this office by the date mentioned at the end of this letter, then proceeding under Section 17 of the NCTE Act shall be brought to logical conclusion without any further opportunity provided in the matter whatsoever.

8. It is expected that your reply shall reach in this office through Courier/Registered AD/Speed Post only. NCTE does not expect applicant to personally visit the Eastern Regional Committee Office for any reason whatsoever.

9. Your reply, being complete in all respects must reach this office on or before 30 days i.e. 21/09/2022.

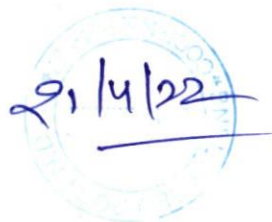
