WITHDRAWAL ORDER		

WHEREAS, in terms of Section 14/15 of the NCTE Act, 1993, the recognition was granted to Dr. Ambedkar Hindi Sanskrit Vidyapeeth Bihar Cum Education & Training, Plot/Khasra No-75/318, 319, 324 & 329, Plot No-75, Vill-Jokia, Post Office-Jokia, Tehsil-Begusarai, Town-Begusarai, Dist.-Begusarai, State-Bihar, Pin Code- 851127 for conducing D.El.Ed. programme with an intake of 50 seats *vide* order No. ERC/7-107.7.1/ 2010/3927 dated 14.05.2010 from the session 2009-2010.

2. AND WHEREAS, the original file of the institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, order dated 28.03.2022 in S.L.P.(C) No.27335/2018 by Hon'ble Supreme Court of India, arising out of L.P.A. No.929/2017 passed by Hon'ble High Court of Judicature at Patna and based on inquiry report of the Bihar School Examination Board considered by the Apex Court wherein it is stated that no such institution was existing at the given place. Accordingly, in light of the aforesaid order, the matter was placed before the Committee and was carefully considered by ERC and the Committee decided as under:-

"The matter be referred to NCTE Hqrs. (Inspection Division) for inspection U/s 13 of NCTE Act, 1993."

Hence, the Committee decided that the matter be referred to NCTE Hqrs. (Inspection Division) for inspection U/s 13 of NCTE Act, 1993".

3. AND WHEREAS, the letter was sent to the inspection division on dated 21.04.2022 for conduct the inspection. The inspection was conducted on 30.05.2022 to 31.05.2022.

4. **AND WHEREAS, visiting report** was considered ERC in its 309th (Virtual) Meeting (Part-2) held on 14th and 15th September, 2022, and the committee decided to issue the 1st show cause notice on dated 22.09.2022. Reply of the institution received on dated 12.10.2022. The matter wasconsidered ERC in its 312th (Virtual) Meeting held on 17th October, 2022 and the committee decided to issue final show cause notice to the institution. Accordingly, the final show cause notice was issued to the institution on dated 19.10.2022. The institution has submitted representation dated 01.11.2022 received on 01.11.2022.

5. AND WHEREAS, the original file of the institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, was considered by ERC in its 313th (virtual) meeting held on 16.11.2022 and the Committee observed that:

- Due to the natural calamity in the year 2020, the structure of the institution collapsed.
- The management of this institute has temporarily shifted this institute to another building. The management of the institute intends to construct a new building at its old place i.e. Jokia for conduct of the said D.El.Ed.
- The institution has not submitted the Essential Data Sheet as per provision of Clause 8(5) and 7(7) of the NCTE Regulations, 2014.
- The institutional website (www.vidyatime.com) is not maintained and updated as per Clause 7(14)(i) of NCTE Regulations, 2014. Relevant documents including approved faculty list are not uploaded on the institutional website.
- The institution has not submitted the Non-Encumbrance Certificate issued by the Competent Authority indicating that the land is free from all encumbrances.
- Building Safety Certificate issued by the competent authority is not submitted
- Fire safety Certificate issued by the competent authority is not submitted
- A certificate to the effect that the institutional campus, building furniture is disabled friendly as per the Persons with Disability (PWD) and of the Government of India is not submitted.
- The institution has submitted the Building Completion Certificate (BCC) which is not as per NCTE Regulation, 2014 & Built up area is not mentioned in the Building Plan.
- The institution has not uploaded the Land Use Certificate issued by the Competent Authority to use the land for educational purpose.
- The institution has not submitted Non-Encumbrance Certificate (NEC) signed by the Competent Govt. Authority.
- The VT members have mentioned the remarks regarding Mutation of the land i.e. "Applied for getting mutation vide application dated 25.01.2022".
- The VT members have mentioned the remarks for Computer Lab i.e. "Seen in dumped states hence, VTs were unable to see these all".
- The VT members have mentioned the remarks for "Art and Craft, Health and Physical Resource Centre (including yoga) & Library cum Resource Centre" that all are flowed in the flood, hence all material were in dumped state; as per informed by the Management.
- In addition to the above, the institution has itself admitted that the institution has temporarily been shifted to another building at Beghi, P.O. Sohid Nagar, Distt-Begusarai. The institution has neither submitted any formal application for shifting of its premises nor the ERC ever permitted for the same.
- The institution has submitted list of teaching faculty which is neither in the prescribed format of NCTE nor the educational qualification/experience of the teaching staff are mentioned therein.
- The institution has submitted building completion certificate dated 15.12.2008 which is approved by Junior Engineer, Building Construction Dept. Govt. of Bihar, Barauni, Begusarai, Bihar, however, the same is not in prescribed format.

The Committee noted that the institution vide its replies dated 12.10.2022 and 01.11.2022 has neither submitted point-wise reply nor forwarded any documents.

Hence, Committee decided that the recognition for B.Ed. Programme be withdrawn under Section 17 (1) of the NCTE Act, 1993 with effect from the end of academic session next following the date of communication of withdrawal order".

6. NOW THEREFORE, in terms of above decision of ERC, the recognition granted to Dr. Ambedkar Hindi Sanskrit Vidyapeeth Bihar Cum Education & Training, Plot/Khasra No-75/318, 319, 324 & 329, Plot No-75, Vill-Jokia, Post Office-Jokia, Tehsil- Begusarai, Town- Begusarai, District-Begusarai, State- Bihar, Pin Code-851127 for D.El.Ed. programme vide order No. ERC/7-107.7.1/2010/3927 dated 14.05.2010 is hereby withdrawn for conducting D.El.Ed. programme under Section 17(1) of NCTE Act, 1993 with effect from the end of academic session next following the date of communication of this withdrawal order.

7. Further, if the institution is not satisfied by the order, they can prefer an appeal under Section 18 of the NCTE Act, 1993 in the "Online mode" available on NCTE's website www.ncte.gov.in within 60 days from the date of the issue of the order.
