Sub: <u>Providing reasonable opportunity for making written representation before</u> withdrawal of recognition under section 17 of NCTE Act, 1993-reg.

Sir/Madam,

In terms of Section 14 (3)(a)/15 (3) (a) of the NCTE Act, 1993, the Eastern Regional Committee grated recognition to No. Goaltore Educational Training Institute Vill.-Subalbandi, P.O-Jirapara, Tehsil/Taluka-Goaltore, Dist.-Midnapore, West Bengal-721121for conducting D.El.Ed vide recognition Order No. ERC/7-170.6.9/NCTE/D.El.Ed/2014/24326 dated: 03-03-2014 with annual intake of 50 students.

2. The matter was considered by ERC in its 306th meeting held on 12th& 13th July, 2022 and the committee *inter-alia* decided as under:-

The Show cause notice under section 17 (1) of NCTE Act, 1993 be issued to the all institutions which have not filed PAR on the ground that the institution has breached the condition of recognition as per the provision of clause 8 (12) of NCTE Regulations, 2014.

Accordingly, show cause notice was issued to the institution on 12.08.2022. The institution has not submitted any reply.

- 3. The matter was again considered by ERC in its 311th (Virtual) meeting held on 11th October, 2022 and the committee *inter-alia* decided as under:-
 - The case of the institution which were not filed the PAR was considered by the ERC in its 306th meeting held 12th & 13th July, 2022 and as per decision of the Committee, the Show cause notice under section 17 (1) of NCTE Act, 1993 was issued on the ground that the institution has breached the condition of recognition as per the provision of clause 8 (12) of NCTE Regulations, 2014 and

- also clause 7 (14) of NCTE, Regulations, 2014 which is related to uploading information on the website, if the web site of the institution is not working.
- It is observed by the ERC that the following institutions have not submitted the reply to SCN issued to them.

Hence, the Committee decided that Final Show Cause Notice be issued before withdrawal of recognition under Section 17 of the NCTE Act, 1993 to submit reply within 15 days from the date of issue of Final Show Cause Notice.

- 4. You are hereby required to show cause as to why recognition granted to your institution for conducting **D.El.Ed.** programme vide above referred Recognition Order should not be withdrawn under Section 17 of NCTE Act, 1993.
- 5. In terms of decision taken by ERC, you are requested to submit your written representation within 15 days from the date of issue of this final show cause notice. No further opportunity shall be provided in this regard.
