## FINAL SHOW CAUSE NOTICE U/S 17

WHEREAS, recognition was granted by the Eastern Regional Committee to Nalanda Teacher's Training College, Mohalla-Kalyanpur, Station Road, Biharsarif, Dist- Nalanda, Bihar - 803101 (APE00806) vide Order No. ERC/7-85.6(II).16/2008/10969 (30) dated 30.04.2008 for B.Ed. Course of one year duration with an annual intake of 100 students from the session 2008-2009, followed by revised order vide No.32765 dt.31.05.2015 from the academic session 2015-2016 as per NCTE, Regulation, 2014 subject to fulfillment of the conditions in respect of the enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

- AND WHEREAS, in compliance of revised recognition institution submitted reply dt.05.02.2018 received on 12.03.2018. The matter was placed before ERC in its 266th meeting held on 31st January, 2019 and after considering the original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, a Show Cause Notice issued to the institution on 14.02.2019.
- AND WHEREAS, in response to Show Cause Notice, institution has submitted reply dt.18.12.2019 received on 20.12.2019. The matter was placed before the ERC in its 278th meeting held on 16th-18th January, 2020 and after considering the original file of the institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by ERC and the following observation was made:
  - i. Teaching faculty mentioned at Sl. No.6, II & 13 do not possess NET/Ph.D. qualification as per amendment Gazette Notification dated 09.06.2017.
  - ii. Certified copy of Fire Safety Certificate duly signed by the Govt. competent Authority to be submitted.
  - iii. Requisite information of the institutional website has not updated as per clause 7(14)(i) of the NCTE Regulation, 2014.

Hence, Final Show Cause Notice under section 17(1) of the NCTE Act, 1993 be issued to the institution to submit reply within 21 days from the date of issue of show cause notice.

NOW, THEREFORE, the institution is required to submit the representation/ compliance accompanied with an affidavit from the authorized representative of the Management. The representation along with an affidavit must reach this office within the time specified at the end.

In case the reply submitted is incomplete or factually incorrect or not received in this office by the date mentioned at the end of this letter, then it shall be treated as incomplete reply to the terms of this notice.
